



NOTICE OF INTENT TO INTRODUCE A BILL Pursuant to the Constitution and laws of the State of Texas, notice is hereby given of the intention to apply to the 85th Legislature of the State of Texas at its regular session in Austin, Texas for the introduction of a bill, the substance of the contemplated law being as follows:
An act relating to the creation of the Vision East Municipal Utility District No. 1 of Travis County; providing authority to impose a tax and issue bonds. The Act proposes to create an MUD District to enhance Economic Development to be known as Vision East Municipal Utility District No. 1 of Travis County, becoming 29.92 acres in Travis County, more particularly described as follows: 4 tracts generally located west of SH130, north of FM973, south of Bloor Road and east of Walter E. Long Metropolitan Park. The District's creation is subject to approval at a confirmation election. All interested persons will, therefore, take notice of the matters and facts set out in the foregoing statement of the substance of the contemplated laws as required by the Constitution and laws of the State of Texas.
