4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Subchapter C, Chapter 662, Government Code, is  
6 amended by adding Section 662.065 to read as follows:

7 Sec. 662.065. BREAST RECONSTRUCTION AWARENESS DAY. (a)  
8 October 19 is Breast Reconstruction Awareness Day to promote  
9 education, awareness, and access for women considering  
10 post-mastectomy breast reconstruction.

11 (b) Breast Reconstruction Awareness Day shall be regularly  
12 observed by appropriate programs and activities.

13 SECTION 2. This Act takes effect immediately if it receives  
14 a vote of two-thirds of all the members elected to each house, as  
15 provided by Section 39, Article III, Texas Constitution. If this  
16 Act does not receive the vote necessary for immediate effect, this  
17 Act takes effect September 1, 2017.
