A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of a task force to identify opportunities
3	for academic credit and industry recognition for inmates of the

5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Chapter 19, Education Code, is amended by adding
7	Section 19.012 to read as follows:
8	Sec. 19.012. TASK FORCE ON ACADEMIC CREDIT AND INDUSTRY
9	RECOGNITION. (a) The Windham School District, in consultation
10	with the department, shall establish a task force to review the work
11	or other productive activities in which persons confined or
12	imprisoned in the department engage.
13	(b) The task force is composed of the following 10 members:
14	(1) two representatives of the department designated
15	by the executive director of the department;
16	(2) one representative of the district designated by
17	the superintendent of the district;
18	(3) one representative of the Texas Higher Education
19	Coordinating Board designated by the commissioner of higher
20	education;
21	(4) one representative of the Texas Workforce
22	Commission designated by the executive director of the commission;
23	(5) one representative of a private vendor operating a
24	correctional facility under a contract with the department,

- 1 appointed by the governor;
- 2 (6) three representatives of public junior colleges,
- 3 as defined by Section 61.003, appointed by the governor, including:
- 4 (A) at least one representative of a public
- 5 junior college that provides education services to persons confined
- 6 or imprisoned in the department; and
- 7 (B) at least one representative of a public
- 8 junior college that does not provide services described by
- 9 Paragraph (A); and
- 10 (7) one representative of a faith-based organization,
- 11 appointed by the governor.
- 12 (c) The governor shall designate a member of the task force
- 13 to serve as presiding officer.
- 14 (d) A vacancy on the task force shall be filled in the same
- 15 manner as the initial appointment.
- (e) A member of the task force may not receive compensation
- 17 for service on the task force, but is entitled to reimbursement for
- 18 actual and necessary expenses incurred in performing task force
- 19 duties.
- 20 (f) The task force may accept gifts and grants from any
- 21 source to be used to carry out a function of the task force.
- 22 <u>(g) The task force shall meet at least quarterly at the call</u>
- 23 of the presiding officer and at other times as determined by the
- 24 presiding officer.
- 25 (h) The task force shall:
- 26 (1) conduct an ongoing comprehensive review of the
- 27 work or other productive activities in which persons confined or

- 1 imprisoned in the department engage; and
- 2 (2) identify opportunities for the award of high
- 3 school credit, college credit, or joint high school and college
- 4 credit, or the award of an industry-recognized credential or
- 5 certificate, for engaging in that work or activity.
- 6 (i) The district, in consultation with the department, the
- 7 Texas Education Agency, the Texas Higher Education Coordinating
- 8 Board, and the Texas Workforce Commission, shall for any type of
- 9 work or productive activity for which an opportunity is identified
- 10 under Subsection (h), determine the actions necessary for obtaining
- 11 the award of the applicable academic credit or industry
- 12 recognition.
- (j) Not less than once every four years, the task force
- 14 shall submit to the governor, the lieutenant governor, the speaker
- of the house of representatives, and the standing committees of the
- 16 <u>legislature having jurisdiction over the department a report that</u>
- 17 summarizes the review conducted under Subsection (h) and the
- 18 district's actions with regard to obtaining the award of academic
- 19 credit or industry recognition under Subsection (i). The district
- 20 shall provide the task force with any information necessary to
- 21 <u>complete the report.</u>
- (k) Chapter 2110, Government Code, does not apply to the
- 23 <u>task force established under this section.</u>
- 24 (1) The task force shall submit the first report required
- 25 under Subsection (j) not later than December 31, 2020. This
- 26 subsection expires February 1, 2021.
- SECTION 2. Not later than December 1, 2017, the executive

- 1 director of the Texas Department of Criminal Justice, the
- 2 superintendent of the Windham School District, the commissioner of
- 3 higher education, the executive director of the Texas Workforce
- 4 Commission, and the governor shall appoint members to the task
- 5 force established by Section 19.012, Education Code, as added by
- 6 this Act, in the manner required by Subsection (b) of that section.
- 7 SECTION 3. This Act takes effect September 1, 2017.
