- 13 (b) The <u>suicide prevention</u> programs on the list must include 14 components that provide for training counselors, teachers, nurses, 15 administrators, and other staff, as well as law enforcement 16 officers and social workers who regularly interact with students, 17 to:
- (1) recognize students at risk of committing suicide, including students who are or may be the victims of or who engage in bullying;
- (2) recognize students displaying early warning signs and a possible need for early mental health or substance abuse intervention, which warning signs may include declining academic performance, depression, anxiety, isolation, unexplained changes in sleep or eating habits, and destructive behavior toward self and others; and
- 27 (3) intervene effectively with students described by

- 1 Subdivision (1) or (2) by providing notice and referral to a parent
- 2 or guardian so appropriate action, such as seeking mental health or
- 3 substance abuse services, may be taken by a parent or guardian.
- 4 (c) In developing the list of <u>best practice-based</u> programs
- 5 and research-based practices, the department and the Texas
- 6 Education Agency shall consider:
- 7 (1) any existing suicide prevention method developed
- 8 by a school district; and
- 9 (2) any Internet or online course or program developed
- 10 in this state or another state that is based on best practices
- 11 recognized by the Substance Abuse and Mental Health Services
- 12 Administration or the Suicide Prevention Resource Center.
- SECTION 2. Section 21.044(c-1), Education Code, is amended
- 14 to read as follows:
- 15 (c-1) Any minimum academic qualifications for a certificate
- 16 specified under Subsection (a) that require a person to possess a
- 17 bachelor's degree must also require that the person receive, as
- 18 part of the training required to obtain that certificate,
- 19 instruction regarding mental health, substance abuse, and youth
- 20 suicide. The instruction required must:
- 21 (1) be provided through a program selected from the
- 22 list of recommended best practice-based programs and
- 23 research-based practices established under Section 161.325, Health
- 24 and Safety Code; and
- 25 (2) include effective strategies for teaching and
- 26 intervening with students with mental or emotional disorders,
- 27 including de-escalation techniques and positive behavioral

- 1 interventions and supports.
- 2 SECTION 3. This Act takes effect immediately if it receives
- 3 a vote of two-thirds of all the members elected to each house, as
- 4 provided by Section 39, Article III, Texas Constitution. If this
- 5 Act does not receive the vote necessary for immediate effect, this
- 6 Act takes effect September 1, 2017.
