Sec. 1001.109. INFORMATION RELATING TO TRAFFIC STOPS. (a) The commission by rule, in consultation with the Department of Public Safety and regional leaders in driver education and law enforcement appointed under Subsection (b), shall require that information relating to law enforcement procedures for traffic stops be included in the curriculum of each driver education and driving safety course. The curriculum must include a demonstration of the proper actions to be taken during a traffic stop and information regarding appropriate interactions with law enforcement.

(b) The advisory committee appointed under Section 1001.058 shall assist in the development of the driver education and driving safety course curriculum requirements under Subsection (a).
