23	on college, career, and military readiness indicators evaluated
24	under the student achievement domain under Section 39.053(c)(1);
25	(3) assign at least one district-level administrator
26	or employee of the regional education service center for the
27	district's region to:
28	(A) coordinate implementation of the plan; and
29	(B) submit an annual report to the board of
