- Amend C.S.H.B. No. 3 (house committee printing) as follows:
- 2 (1) Add the following appropriately numbered SECTION to
- 3 ARTICLE 1 of the bill and renumber subsequent SECTIONS of that
- 4 ARTICLE accordingly:
- 5 SECTION 1.\_\_\_\_. Subchapter D, Chapter 48, Education Code,
- 6 as added by this Act, is amended by adding Section 48.1532 to read
- 7 as follows:
- 8 Sec. 48.1532. ALLOTMENT FOR SALARY INCREASES FOR CERTAIN
- 9 PROFESSIONAL EMPLOYEES. (a) A school district is entitled to an
- 10 allotment in an amount equal to the product of \$5,000 multiplied by
- 11 the number of classroom teachers, full-time librarians, full-time
- 12 school counselors certified under Subchapter B, Chapter 21, and
- 13 <u>full-time school nurses employed</u> by the district.
- 14 (b) A school district that is required to take action under
- 15 Chapter 49 to reduce its local revenue level to the level
- 16 established under Section 48.257 is entitled to a credit, in the
- 17 amount of the allotment to which the district is entitled under this
- 18 section, against the total amount required under Section 49.153 for
- 19 the district to purchase attendance credit.
- 20 (c) The commissioner may adopt rules to implement this
- 21 section.
- 22 (2) Add the following appropriately numbered SECTION to
- 23 ARTICLE 2 of the bill and renumber subsequent SECTIONS of that
- 24 ARTICLE accordingly:
- 25 SECTION 2.\_\_\_. Section 21.402, Education Code, is amended
- 26 by adding Subsections (c-2), (c-3), and (d) to read as follows:
- 27 (c-2) Notwithstanding Subsection (a), for the 2019-2020
- 28 school year, a classroom teacher, full-time librarian, full-time
- 29 school counselor certified under Subchapter B, or full-time school

- 1 nurse is entitled to a monthly salary that is at least equal to the
- 2 sum of:
- 3 (1) the monthly salary the employee would have
- 4 received for the 2019-2020 school year under the district's salary
- 5 schedule for the 2018-2019 school year, if that schedule had been in
- 6 effect for the 2019-2020 school year, including any local
- 7 supplement and any money representing a career ladder supplement
- 8 the employee would have received in the 2019-2020 school year; and
- 9 (2) \$500.
- 10 (c-3) Subsection (c-2) and this subsection expire September
- 11 1, 2020.
- 12 (d) A classroom teacher, full-time librarian, full-time
- 13 school counselor certified under Subchapter B, or full-time school
- 14 nurse employed by a school district in the 2019-2020 school year is,
- 15 as long as the employee is employed by the same district, entitled
- 16 to a salary that is at least equal to the salary the employee
- 17 received for the 2019-2020 school year.
