28 Article 5 of the bill and renumber subsequent SECTIONS of that
29 article accordingly:

30 SECTION 5.____. Sections 48.273 and 48.274, Education Code,
31 as transferred, redesignated, and amended by this Act, apply only

1 to a payment from the foundation school fund that is made on or
2 after September 1, 2019. A payment from the foundation school fund
3 to a school district or open-enrollment charter school that is made
4 before that date is governed by the law in effect before the
5 effective date of this Act, and the former law is continued in
6 effect for that purpose.
