1 Amend C.S.H.B. No. 3 (house committee printing) as follows: 2 (1) Add the following appropriately numbered SECTION to ARTICLE 1 of the bill and renumber subsequent SECTIONS of that 3 4 ARTICLE accordingly: 5 SECTION 1.___. Subchapter D, Chapter 48, Education Code, as added by this Act, is amended by adding Section 48.1532 to read 7 as follows: 8 Sec. 48.1532. ALLOTMENT FOR SALARY INCREASES FOR CERTAIN 9 PROFESSIONAL EMPLOYEES. (a) A school district is entitled to an allotment in an amount equal to the product of \$3,500 multiplied by 10 the number of classroom teachers, full-time librarians, full-time 11 12 school counselors certified under Subchapter B, Chapter 21, and 13 full-time school nurses employed by the district. 14 (b) A school district that is required to take action under Chapter 49 to reduce its local revenue level to the level 15 established under Section 48.257 is entitled to a credit, in the 16 17 amount of the allotment to which the district is entitled under this 18 section, against the total amount required under Section 49.153 for 19 the district to purchase attendance credit. 20 (c) The commissioner may adopt rules to implement this 21 section. 22 (2) Add the following appropriately numbered SECTION to ARTICLE 2 of the bill and renumber subsequent SECTIONS of that 23 ARTICLE accordingly: 24 25 SECTION 2.___. Section 21.402, Education Code, is amended 26 by adding Subsections (c-2), (c-3), and (d) to read as follows: 27 (c-2) Notwithstanding Subsection (a), for the 2019-2020 28 school year, a classroom teacher, full-time librarian, full-time

school counselor certified under Subchapter B, or full-time school

- 1 nurse is entitled to a monthly salary that is at least equal to the
- 2 sum of:
- 3 (1) the monthly salary the employee would have
- 4 received for the 2019-2020 school year under the district's salary
- 5 schedule for the 2018-2019 school year, if that schedule had been in
- 6 effect for the 2019-2020 school year, including any local
- 7 supplement and any money representing a career ladder supplement
- 8 the employee would have received in the 2019-2020 school year; and
- 9 (2) \$350.
- 10 (c-3) Subsection (c-2) and this subsection expire September
- 11 1, 2020.
- 12 (d) A classroom teacher, full-time librarian, full-time
- 13 school counselor certified under Subchapter B, or full-time school
- 14 nurse employed by a school district in the 2019-2020 school year is,
- 15 as long as the employee is employed by the same district, entitled
- 16 to a salary that is at least equal to the salary the employee
- 17 received for the 2019-2020 school year.
