- 1 Amend C.S.H.B. No. 1545 (house committee printing) as 2 follows:
- 3 (1) On page 81, line 5, between "SECTION 90." and "Section",
- 4 insert the following:
- 5 (a) Effective September 1, 2019, Section 24.07, Alcoholic
- 6 Beverage Code, is amended to read as follows:
- 7 Sec. 24.07. WHEN LICENSE ALSO HELD: HOURS OF SALE, ETC. A
- 8 holder of a wine only package store permit who also holds a retail
- 9 dealer's off-premise license for the same location may remain open
- 10 and sell ale, wine, vinous liquors, and beer, for off-premises
- 11 consumption only, on any day and during the same hours as those
- 12 prescribed for the sale of beer under Section 105.05 [that the
- 13 holder of a wine and beer retailer's permit may sell ale, beer, and
- 14 wine], except that the permit holder [he] may not sell wine or
- 15 vinous liquor containing more than 17 percent alcohol by volume on a
- 16 Sunday or after 10 p.m. on any day.
- 17 (b) Effective September 1, 2021,
- 18 (2) On page 81, strike lines 12 through 14, and substitute
- 19 the following:
- 20 and during the same hours as those prescribed for the sale of malt
- 21 beverages under Section 105.05 [that the holder of a wine and beer
- 22 retailer's permit may sell ale, beer, and wine], except that the
- 23 permit holder [he] may not sell wine or
- 24 (3) On page 250, line 23, between "SECTION 315." and
- 25 "Section", insert the following:
- 26 (a) Effective September 1, 2019, Section 105.04, Alcoholic
- 27 Beverage Code, is amended to read as follows:
- 28 Sec. 105.04. HOURS OF SALE: WINE AND BEER RETAILER. The
- 29 hours of sale and delivery for alcoholic beverages sold under a wine

- 1 and beer retailer's permit or a wine and beer retailer's off-premise
- 2 permit are the same as those prescribed for the sale of beer under
- 3 Section 105.05 [of this code, except that no sale shall be allowed
- 4 between 2 a.m. and noon on Sunday].
- 5 (b) Effective September 1, 2021,
- 6 (4) On page 251, strike lines 3 and 4, and substitute the
- 7 following:
- 8 Section 105.05 [of this code, except that no sale shall be allowed
- 9 between 2 a.m. and noon on Sunday].
- 10 (5) On page 251, line 5, between "SECTION 316." and
- 11 "Section", insert the following:
- 12 (a) Effective September 1, 2019, Section 105.05(b),
- 13 Alcoholic Beverage Code, is amended to read as follows:
- 14 (b) A person may sell, offer for sale, or deliver beer
- 15 between 7 a.m. and midnight on any day except Sunday. On Sunday a
- 16 person [he] may sell beer between midnight and 1:00 a.m. and between
- 17 noon and midnight, except that:
- 18 (1) permittees or licensees authorized to sell for
- 19 on-premise consumption may sell beer between 10:00 a.m. and noon if
- 20 the beer is served to a customer during the service of food to the
- 21 customer; and
- 22 (2) holders of a retail dealer's on-premise license or
- 23 <u>a retail dealer's off-premise license may also sell beer for</u>
- 24 off-premise consumption between 10:00 a.m. and noon.
- 25 (b) Effective September 1, 2021,
- 26 (6) On page 251, strike lines 10 through 17, and substitute
- 27 the following:
- 28 (b) A person may sell, offer for sale, or deliver malt
- 29 beverages [beer] between 7 a.m. and midnight on any day except
- 30 Sunday. On Sunday a person [he] may sell malt beverages [beer]
- 31 between midnight and 1:00 a.m. and between noon and midnight,

- 1 except that:
- 2 <u>(1)</u> permittees or licensees authorized to sell for
- on-premise consumption may sell <u>malt beverages</u> [beer] between 10:00
- 4 a.m. and noon if the malt beverages are [beer is] served to a
- 5 customer during the service of food to the customer; and
- 6 (2) holders of a retail dealer's on-premise license or
- 7 <u>a retail dealer's off-premise license may also sell malt beverages</u>
- 8 for off-premise consumption between 10:00 a.m. and noon.
