### **AUTHOR'S / SPONSOR'S STATEMENT OF INTENT**

H.B. 4170 amends current law relating to nonsubstantive additions to, revisions of, and corrections in enacted codes, to the nonsubstantive codification or disposition of various laws omitted from enacted codes, and to conforming codifications enacted by the 85th Legislature to other Acts of that legislature.
