(1) the number of or other identifying information on the person's driver's license or commercial driver's license may not be included in any report of the accident or violation; and

17 (2) the person's involvement in the accident or 18 violation may not be recorded in the person's individual driving 19 record maintained by the <u>Texas</u> Department of <u>Motor Vehicles</u> [Public 20 Safety].

21 SECTION 2. Section 201.806(b), Transportation Code, is

(b) The department shall provide electronic access to the

(h) In each office authorized to issue driver's licenses or personal identification certificates, the <u>Texas</u> Department of <u>Motor Vehicles</u> [Public Safety] shall make available educational materials developed by the nonprofit organization administering the registry.

The Glenda Dawson Donate Life-Texas Registry fund is 19 (i) created as a trust fund outside the state treasury to be held by the 20 comptroller and administered by the <u>Texas</u> Department of <u>Motor</u> 21 Vehicles [Public Safety] as trustee on behalf of the statewide 22 donor registry maintained for the benefit of the citizens of this 23 24 state. The fund is composed of money deposited to the credit of the Sections 502.405(b), 521.008, and 521.422(c), 25 fund under 26 Transportation Code, as provided by those subsections. Money in 27 fund shall be disbursed at least the monthly, without

1 appropriation, to the nonprofit organization administering the 2 registry to pay the costs of:

3 (1) maintaining, operating, and updating the
4 Internet-based registry and establishing procedures for an
5 individual to be added to the registry;

6 (2) designing and distributing educational materials 7 for prospective donors as required under this section; and

(3) providing education under this chapter.

9 (m) The nonprofit organization administering the registry 10 may:

(1) implement a training program for all appropriate <u>Texas</u> Department of <u>Motor Vehicles</u> [Public Safety] and Texas Department of Transportation employees on the benefits of organ, tissue, and eye donation and the procedures for individuals to be added to the Internet-based registry; and

16 (2) conduct the training described by Subdivision (1)17 on an ongoing basis for new employees.

Neither the Texas Department of Motor Vehicles nor the Department 20 of Public Safety may impose or collect a fee or charge in connection 21 with the sharing of information under the joint memorandum of 22 23 understanding entered into or revised under this section.

(b) The Texas Department of Motor Vehicles and the
 Department of Public Safety shall implement the joint memorandum of
 understanding using existing personnel and resources.

27 (c) Otherwise confidential information shared under the

1 memorandum of understanding remains subject to the same 2 confidentiality requirements and legal restrictions on access to 3 the information that are imposed by law on the department that 4 originally obtained or collected the information.

5 (d) Information may be shared under the memorandum of 6 understanding without the consent of the person who is the subject 7 of the information.

8 (e) The memorandum of understanding required by Subsection 9 (a) of this section must be entered into or revised at the first 10 official meeting of the board of the Texas Department of Motor 11 Vehicles occurring after the effective date of this Act.

SECTION 118. (a) Tn addition to the memorandum 12 of understanding required by this Act, the governing bodies of the 13 Texas Department of Motor Vehicles and the Department of Public 14 15 Safety may enter into or revise one or more other joint memoranda of understanding necessary to effect the transfer of the powers and 16 17 duties of the Department of Public Safety to the Texas Department of Motor Vehicles under this Act. A memorandum of understanding may 18 include an agreement for the provision of office space, utilities, 19 and other facility services; the need for full-time equivalent 20 positions of the Department of Public Safety to provide support 21 services in addition to the positions transferred to the Texas 22 Department of Motor Vehicles under this Act; other support 23 24 services; and the transfer of information technology as necessary or appropriate to effect the transfer of the powers and duties of 25 26 the Department of Public Safety to the Texas Department of Motor Vehicles. 27

1 (b) Subsections (b), (c), and (d) of Section 117 of this Act 2 apply to a memorandum of understanding entered into or revised 3 under Subsection (a) of this section.

4 SECTION 119. To the extent of any conflict, this Act 5 prevails over another Act of the 86th Legislature, Regular Session, 6 2019, relating to nonsubstantive additions to and corrections in 7 enacted codes.

8 SECTION 120. This Act takes effect immediately if it 9 receives a vote of two-thirds of all the members elected to each 10 house, as provided by Section 39, Article III, Texas Constitution. 11 If this Act does not receive the vote necessary for immediate 12 effect, this Act takes effect September 1, 2019.
