4	SECTION 1. Section 73.009(a), Human Resources Code, is
5	amended to read as follows:
6	(a) The <u>commission</u> [department] shall develop and the
7	executive commissioner shall establish policies concerning
8	services described by this section. A child under three years of
9	age and the child's parent, guardian, or other legally authorized
10	representative [family] may be referred for services described by
11	this section if the child is:
12	(1) identified as having a developmental delay;
13	(2) suspected of having a developmental delay; or
14	(3) considered at risk of developmental delay.
15	SECTION 2. Chapter 73, Human Resources Code, is amended by
16	adding Sections 73.0111 and 73.012 to read as follows:
17	Sec. 73.0111. PROVIDER OMBUDSMAN. (a) In this section,
18	"ombudsman" means the individual designated as the ombudsman for
19	providers of services authorized under this chapter.
20	(b) The executive commissioner shall designate an ombudsman
21	for providers of services authorized under this chapter.
22	(c) The ombudsman's office is administratively attached to
23	the office of the ombudsman of the commission.
24	(d) The commission may use an alternate title for the

4	(e) The ombudsman serves as a neutral party to assist
5	providers of services authorized under this chapter in resolving

7	under this chapter, including through the STAR Kids managed care
8	program.
9	(f) The ombudsman shall:
10	(1) provide dispute and complaint resolution
11	services;
12	(2) perform provider protection and advocacy
13	functions;
14	(3) collect inquiry and complaint data; and
15	(4) at least annually, submit a report to the
16	commission relating to the inquiry and complaint data collected
17	under Subdivision (3) and make recommendations to the commission on

26	MANAGEMENT SERVICES. (a) The executive commissioner shall request
27	clear direction and guidance from the federal Centers for Medicare

No. 12 1 and Medicaid Services on the reimbursement methodology that may be 2 used for the provision of case management services under this 3 chapter, including direction on allowable and unallowable costs. 4 (b) This section expires September 1, 2021. 5 SECTION 3. Subtitle B, Title 3, Human Resources Code, is amended by adding Chapter 74 to read as follows: 6 7 CHAPTER 74. TELE-CONNECTIVE PILOT PROGRAM Sec. 74.0001. DEFINITIONS. In this chapter: 8 (1) "Commission" means the Health and Human Services 9 10 Commission. (2) "Education service center region" means a 11 12 geographic region served by a regional education service center under Chapter 8, Education Code. 13 14 (3) "Eligible child" means a child who is eligible for 15 early childhood intervention services under Chapter 73. 16 (4) "Executive commissioner" means the executive commissioner of the Health and Human Services Commission. 17 (5) "Tele-connective pilot program" means the program 18 19 developed and implemented under Section 74.0002. (6) "Telehealth service" and "telemedicine medical 20 service" have the meanings assigned by Section 111.001, Occupations 21 22 Code. Sec. 74.0002. TELE-CONNECTIVE PILOT PROGRAM. (a) 23 The 24 commission shall develop and implement a pilot program to provide early childhood intervention services under Chapter 73 to eligible 25 26 children through the provision of telehealth and telemedicine medical services delivered using access points established in one 27

13	Sec. 74.0003. EDUCATION SERVICE CENTER REGION SELECTION.
14	The commission in cooperation with the Texas Education Agency shall
15	select the education service center regions in which to implement
16	the tele-connective pilot program. In determining the regions in
17	which to implement the program, the commission and the Texas
18	Education Agency shall:
19	(1) consider each region in which there is:
20	(A) a low or inadequate number of service
21	providers authorized under Chapter 73; or
22	(B) a significant risk of losing service

ADEQUATE NETWORK OF ACCESS POINTS. (a) The 7 commission, in consultation with the Texas Education Agency, shall: 8 (1) establish any school-based provider access points under the tele-connective pilot program; and 9 10 (2) ensure that an adequate number of school-based and non-school-based access points are established in education 11 12 service center regions participating in the program. (b) When selecting access points in which to implement the 13 14 tele-connective pilot program, the commission and the Texas 15 Education Agency shall consider the availability of existing 16 infrastructure. 17 Sec. 74.0006. AUTOMATIC AND VOLUNTARY PARTICIPATION OF CERTAIN ELIGIBLE CHILDREN. (a) Subject to Subsection (b), the 18 19 executive commissioner shall, after receiving recommendations from the advisory committee established under Section 73.004, by rule 20 establish which eligible children will be automatically enrolled in 21 22 the tele-connective pilot program. (b) The parent, guardian, or other legally authorized 23 24 representative of an eligible child may, at any time, elect to opt the child out of the tele-connective pilot program. 25 26 (c) A child who is enrolled in the tele-connective pilot

SCHOOL DISTRICT EMPLOYEE TRAINING. The Texas Education Agency shall develop a training course on the 6 7 tele-connective pilot program to be given to appropriate school 8 district employees. Sec. 74.0008. INITIAL SCREENING AND EVALUATION. (a) 9 The 10 parent, guardian, or other legally authorized representative of an eligible child must be: 11 12 (1) present during an initial screening or evaluation 13 under the tele-connective pilot program; and 14 (2) given the opportunity to opt the child out of the 15 tele-connective pilot program at the time of the child's initial 16 screening or evaluation. 17 (b) Notwithstanding any other law, after a child is enrolled in the tele-connective pilot program, early childhood intervention 18 19 services, including any initial treatment or prescription, that are delivered or issued by a physician or by a health care provider 20 acting under the delegation or supervision of the physician or 21 under the health care provider's license may be provided using 22 23 telecommunications or other information technology. Sec. 74.0009. PROVIDER REIMBURSEMENT. The executive 24 commissioner in adopting rules governing the tele-connective pilot 25 26 program shall ensure that provider reimbursement for a telehealth

or telemedicine medical service is made at a rate that is comparable

1 to the rate paid under Medicaid for the provision of the same or 2 substantially similar services. Sec. 74.0010. CONFIDENTIALITY OF INFORMATION. 3 The commission shall ensure that the tele-connective pilot program 4 5 complies with federal and state law regarding confidentiality of medical information, including the Health Insurance Portability 6 7 and Accountability Act of 1996 (42 U.S.C. Section 1320d et seq.) and 8 the Family Educational Rights and Privacy Act of 1974 (20 U.S.C. Section 1232g). 9 10 Sec. 74.0011. ACCESS POINT EVALUATION. Not later than September 1, 2020, the commission shall conduct an evaluation of 11 12 the tele-connective pilot program to ensure that an adequate number of access points have been established in each education service 13 center region selected for implementation of the program. 14 This 15 section expires January 1, 2021. Sec. 74.0012. REPORT. Not later than January 1, 2021, the 16 17 commission shall submit an initial report to the governor, the lieutenant governor, the speaker of the house of representatives, 18 19 and the presiding officers of the standing committees of the senate and house of representatives having primary jurisdiction over the 20 early childhood intervention program authorized by Chapter 73. The 21 22 report must evaluate the operation of the tele-connective pilot program and make recommendations regarding the continuation or 23 24 expansion of the program. Sec. 74.0013. FUNDING. The commission shall actively seek 25 26 and apply for any available federal money to support the tele-connective pilot program, including federal money made 27

1 available by the: 2 (1) Federal Communications Commission, including money available under the federal Rural Health Care Program; 3 4 (2) United States Health Resources and Services 5 Administration's Office for the Advancement of Telehealth; and 6 (3) United States Department of Agriculture, 7 including the Distance Learning and Telemedicine Grant Program 8 established under 7 C.F.R. Part 1734. 9 Sec. 74.0014. EXPIRATION. This chapter expires September 10 1, 2023. SECTION 4. Subchapter A, Chapter 302, Labor Code, 11 is 12 amended by adding Section 302.0061 to read as follows: Sec. 302.0061. WORKFORCE DEVELOPMENT GRANTS FOR PROVIDERS 13 UNDER EARLY CHILDHOOD INTERVENTION PROGRAM. (a) In this section, 14 15 "early childhood intervention program" means the program established under Chapter 73, Human Resources Code, to provide 16 17 early childhood intervention services in accordance with Part C, Individuals with Disabilities Education Act (IDEA)(20 U.S.C. 18 19 Section 1431 et seq.). (b) The commission shall actively seek and apply for federal 20 funding to establish a program designed to provide workforce 21 development grants to providers participating in the early 22 childhood intervention program for purposes of improving the 23 24 provision of program services by offering providers appropriate education and training. 25 SECTION 5. (a) The Health and Human Services Commission 26 27 shall request guidance from the federal Centers for Medicare and

Medicaid Services or other appropriate federal agency regarding the feasibility of receiving a waiver or other authorization necessary to provide through Medicaid early childhood intervention services to children who are eligible to receive those services under Chapter 73, Human Resources Code, as amended by this Act, but who are not eligible for Medicaid and do not have private health benefits coverage.

8 (b) As soon as practicable after receiving guidance under Subsection (a) of this section, the Health and Human Services 9 10 Commission shall prepare a report on how best to provide to children the coverage described by that subsection. The commission shall 11 12 submit the report to the governor, the lieutenant governor, the speaker of the house of representatives, and the presiding officers 13 14 of the standing committees of the senate and house of 15 representatives having primary jurisdiction over the early childhood intervention program authorized by Chapter 73, Human 16 17 Resources Code, as amended by this Act.

SECTION 6. (a) As soon as practicable after the effective 18 19 date of this Act, the Health and Human Services Commission, after 20 consulting with the Texas Education Agency, other appropriate state agencies, and the advisory committee established under Section 21 73.004, Human Resources Code, shall conduct a financial evaluation 22 23 of the early childhood intervention services provided under Chapter 24 73, Human Resources Code, as amended by this Act, and report on that evaluation. The report must quantify the amount by which providing 25 26 early childhood intervention services in this state affects other budget strategies, including the budget strategies of school 27

1 districts, regional education service centers, and other affected
2 governmental entities.

Not later than September 1, 2020, the Health and Human 3 (b) Services Commission shall submit the report prepared under 4 5 Subsection (a) of this section to the governor, the lieutenant governor, the speaker of the house of representatives, and the 6 presiding officers of the standing committees of the senate and 7 8 house of representatives having primary jurisdiction over the early childhood intervention program authorized by Chapter 73, Human 9 10 Resources Code, as amended by this Act.

SECTION 7. Not later than December 1, 2019, the Health and Human Services Commission shall issue guidance to health benefit plan issuers clarifying that providers of early childhood intervention services under Chapter 73, Human Resources Code, as amended by this Act, must file claims using the national provider identifier number and Texas provider identifier number.

17 SECTION 8. As soon as practicable after the effective date 18 of this Act, but not later than January 1, 2020, the Health and 19 Human Services Commission shall develop and implement the 20 tele-connective pilot program required by Chapter 74, Human 21 Resources Code, as added by this Act.

SECTION 9. If before implementing any provision of this Act a state agency determines that a waiver or authorization from a federal agency is necessary for implementation of that provision, the agency affected by the provision shall request the waiver or authorization and may delay implementing that provision until the waiver or authorization is granted.

1 SECTION 10. This Act takes effect September 1, 2019.
