 1-20 AN ACT

1-21 relating to reporting information regarding public school
 1-22 disciplinary actions.

1-23 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-24 SECTION 1. The heading to Section 37.020, Education Code,
 1-25 is amended to read as follows:

1-26 Sec. 37.020. REPORTS RELATING TO OUT-OF-SCHOOL
 1-27 SUSPENSIONS, EXPULSIONS, AND DISCIPLINARY ALTERNATIVE EDUCATION
 1-28 PROGRAM PLACEMENTS.

1-29 SECTION 2. Section 37.020, Education Code, is amended by
 1-30 adding Subsection (f) to read as follows:

1-31 (f) For each out-of-school suspension under Section 37.005,
 1-32 the district shall report:

1-33 (1) information identifying the student, including
 1-34 the student's race, sex, and date of birth, that will enable the
 1-35 agency to compare placement data with information collected through
 1-36 other reports;

1-37 (2) information indicating the basis for the
 1-38 suspension;

1-39 (3) the number of full or partial days the student was
 1-40 suspended; and

1-41 (4) the number of out-of-school suspensions that were
 1-42 inconsistent with the guidelines included in the student code of
 1-43 conduct under Section 37.001(a)(3).

1-44 SECTION 3. This Act applies beginning with the 2019-2020
 1-45 school year.

1-46 SECTION 4. This Act takes effect immediately if it receives
 1-47 a vote of two-thirds of all the members elected to each house, as
 1-48 provided by Section 39, Article III, Texas Constitution. If this
 1-49 Act does not receive the vote necessary for immediate effect, this
 1-50 Act takes effect September 1, 2019.
