5	SECTION 1. Section 418.004, Government Code, is amended by
6	adding Subdivision (3-a) to read as follows:
7	(3-a) "Illuminated display" means a device that:
8	(A) displays blue, green, red, and yellow colors
9	or the color white; and
10	(B) displays a flashing light and a continuous

12	SECTION 2. Section 418.015(a), Government Code, is amended
13	to read as follows:
14	(a) An executive order or proclamation declaring a state of

16	(1) activates the disaster recovery and
17	rehabilitation aspects of the state emergency management plan
18	applicable to the area subject to the declaration; [and]
19	(2) authorizes the deployment and use of any forces to
20	which the plan applies and the use or distribution of any supplies,
21	equipment, and materials or facilities assembled, stockpiled, or
22	arranged to be made available under this chapter or other law
23	relating to disasters; and

the disaster identification system described by Section 418.0155. 1 2 SECTION 3. Subchapter B, Chapter 418, Government Code, is 3 amended by adding Section 418.0155 to read as follows: 4 Sec. 418.0155. DISASTER IDENTIFICATION SYSTEM. (a) In an 5 area subject to a declaration of a state of disaster under Section 418.014, a person may use an illuminated display to communicate 6 7 with disaster relief personnel. A person who elects to participate in the disaster identification system shall: 8 9 (1) affix to each individual and domesticated animal 10 in the person's household an illuminated display of the following colors: 11 12 (A) if the person has a monochromatic illuminated display, the color white for each individual and animal; or 13 14 (B) if the person has a multicolored illuminated 15 display: 16 (i) blue for each individual 18 years of age 17 or older; (ii) green for each individual with a 18 19 disability; 20 (iii) red for each individual younger than 21 18 years of age; and (iv) yellow for each animal; and 22 (2) using the illuminated display, signal to disaster 23 24 relief personnel responding to the area after the disaster with: 25 (A) a continuous light on the display of each 26 household member who does not need medical assistance; or 27 (B) a flashing light on the display of each

household member who needs medical assistance. 1 2 (b) Disaster relief personnel may patrol the designated disaster area by air or ground at night to locate persons with 3 activated illuminated displays. 4 5 SECTION 4. Section 418.042(a), Government Code, is amended to read as follows: 6 7 (a) The division shall prepare and keep current а 8 comprehensive state emergency management plan. The plan may include: 9 10 (1)provisions for prevention and minimization of injury and damage caused by disaster; 11 12 (2) provisions for prompt and effective response to disaster; 13 14 (3) provisions for emergency relief; 15 (4) provisions for energy emergencies; identification of areas particularly vulnerable 16 (5) to disasters; 17 for (6) recommendations zoning, 18 building restrictions, and other land-use controls, safety measures for 19 securing mobile homes or other nonpermanent or semipermanent 20 structures, and other preventive and preparedness measures 21 designed to eliminate or reduce disasters or their impact; 22 (7) provisions for assistance to local officials in 23 24 designing local emergency management plans; 25 (8) authorization and procedures for the erection or 26 other construction of temporary works designed to protect against or mitigate danger, damage, or loss from flood, fire, or other 27
