## A BILL TO BE ENTITLED

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Section 33.007, Education Code, is amended by
- 8 amending Subsection (b) and adding Subsection (b-2) to read as
- 9 follows:
- 10 (b) During the first school year a student is enrolled in a
- 11 high school or at the high school level in an open-enrollment
- 12 charter school, and again during each year of a student's
- 13 enrollment in high school or at the high school level, a school
- 14 counselor shall provide information about postsecondary education
- 15 to the student and the student's parent or guardian. The
- 16 information must include information regarding:
- 17 (1) the importance of postsecondary education;
- 18 (2) the advantages of earning an endorsement and a
- 19 performance acknowledgment and completing the distinguished level
- 20 of achievement under the foundation high school program under

- 22 (3) the disadvantages of taking courses to prepare for
- 23 a high school equivalency examination relative to the benefits of
