- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Subchapter A, Chapter 13, Election Code, is
- 7 amended by adding Section 13.009 to read as follows:
- 8 Sec. 13.009. VOTER REGISTRATION THROUGH DEPARTMENT OF
- 9 PUBLIC SAFETY. (a) The voter registrar of each county shall
- 10 automatically register any county resident who is eligible to vote
- 11 as provided by Section 13.001 and:
- 12 <u>(1) is issued a Texas driver's license or a personal</u>
- 13 identification card by the Department of Public Safety; or
- 14 (2) makes a change to a Texas driver's license or
- 15 personal identification card issued by the Department of Public
- 16 Safety.
- 17 (b) A driver's license or personal identification card
- 18 transaction with an indication provided by Section 20.062(b) or
- 19 20.063(c) that the transaction is not for voter registration
- 20 purposes is not subject to this section.
- 21 SECTION 2. Section 20.061, Election Code, is amended to

- 3 SECTION 3. Section 20.062(b), Election Code, is amended to
- 4 read as follows:
- 5 (b) The department shall prescribe and use a change of
- 6 address form and procedure that combines department and voter
- 7 registration functions. The form must allow a licensee or
- 8 cardholder to indicate that [whether] the change of address is not
- 9 [also to be used] for voter registration purposes.
- 10 SECTION 4. Section 20.063, Election Code, is amended to
- 11 read as follows:
- 12 Sec. 20.063. REGISTRATION PROCEDURES. (a) The Department
- 13 of Public Safety shall consider an application made in person, by
- 14 mail, or online at the department's Internet website [provide to
- 15 each person who applies in person at the department's offices] for
- 16 an original or renewal of a driver's license, a personal
- 17 identification card, or a duplicate or corrected license or card by
- 18 a person who is eligible to vote as provided by Section 13.001 an
- 19 application for [opportunity to complete a] voter registration.
- 20 The date of application is considered to be the date of submission
- 21 to the voter registrar for the purpose of determining the effective
- 22 date of registration [application form].
- 23 (b) The Department of Public Safety shall consider a change
- 24 of address that relates to [When the department processes] a
- 25 license or card <u>and that is submitted to</u> [for renewal by mail,] the
- 26 department [shall deliver to the applicant by mail a voter
- 27 registration application form.

[(c) A change of address that relates to a license or card and that is submitted to the department] in person, [or] by mail, or 2 3 online at the department's Internet website [serves] as a change in [of address for] voter registration [unless the licensee or 4 cardholder indicates that the change is not for voter registration purposes]. The date of submission of a change of address to a 6 department employee is considered to be the date of submission to 7 8 the voter registrar for the purpose of determining the effective date of registration [only]. 9

- (c) The registration of an eligible [(d) If a completed] 10 voter as required by Subsections (a) and (b) is automatic unless the 11 person indicates that the transaction is not for voter 12 registration purposes [application submitted to a department 13 employee does not include the applicant's correct driver's license 14 15 number or personal identification card number, a department employee shall enter the appropriate information on the 16 17 application. If a completed application does not include the applicant's correct residence address or mailing address, a 18 department employee shall obtain the appropriate information from 19 the applicant and enter the information on the application]. 20
- 21 SECTION 5. Section 20.065(b), Election Code, is amended to read as follows: 22
- Each weekday the department is regularly open for 23 24 business, the department shall electronically transfer to the secretary of state the name and information designated by the 25 26 secretary of state for [of each person who completes a] voter registration for each individual who is eligible to vote as 27

- 7 SECTION 6. This Act takes effect September 1, 2019.
