16	(3) "Consumer reporting agency" means any person that,
17	for monetary fees or dues or on a cooperative nonprofit basis,
18	regularly engages in the practice of assembling or evaluating
19	credit information or other information on individuals for the
20	purpose of furnishing credit reports to third parties.
21	(4) "Credit report" means any written, oral, or other
22	communication of information by a consumer reporting agency that
23	bears on an individual's creditworthiness, credit standing, credit
24	capacity, or debts.

8 <u>a copy of the credit report relied on by the employer together with</u> 9 <u>written instructions regarding how the employee or applicant, not</u> 10 <u>later than the second business day after the date the employee or</u> 11 <u>applicant receives the credit report and instructions, may provide</u> 12 <u>the employer with information explaining or otherwise addressing</u> 13 <u>the information in the credit report; and</u>

14 (2) either:

15 (A) the employee or applicant has not provided to 16 the employer the information described by Subdivision (1) within 17 the time prescribed by that subdivision; or

18 (B) the employee or applicant provided to the 19 employer the information described by Subdivision (1) within the 20 time prescribed by that subdivision and the employer considered 21 that information before taking the action.

SECTION 2. This Act applies only to an adverse employment action that is taken by an employer against an employee or applicant for employment or other employer conduct that occurs on or after January 1, 2020. Action taken by an employer or other conduct that occurs before January 1, 2020, is governed by the law in effect immediately before the effective date of this Act, and the former

1 law is continued in effect for that purpose.

2 SECTION 3. This Act takes effect September 1, 2019.
