4 (f) A postsecondary educational institution may charge a reasonable fee in connection with the release of a transcript or a 5 certificate of completion of training under this section. 6 The amount of a fee charged under this subsection must be the same for 7 8 each student, except that a postsecondary educational institution may establish a policy that provides for charging a lower fee for 9 10 certain students based on criteria other than whether the student has fulfilled the student's financial obligation to the 11 12 institution.

13 (g) In this section, "postsecondary educational 14 institution" includes an "institution of higher education" and a 15 "private or independent institution of higher education" as those 16 terms are defined by Section 61.003, and a "career school or 17 college" as defined by Section 132.001.

SECTION 2. Section 54.057(b), Education Code, is amended to read as follows:

The person shall pay the applicable amount to the 20 (b) institution not later than the 30th day after the date the person is 21 notified of the person's liability for the amount owed. After 22 receiving the notice and until the amount is paid in full, the 23 person is not entitled to receive from the institution a 24 certificate or diploma, if not yet awarded on the date of the 25 26 notice, [or official transcript] that is based at least partially on [or includes] credit for courses taken while the person was 27

2 SECTION 3. Section 132.055(b)(6), Education Code, is 3 amended to read as follows:

(6) <u>On</u> [Except as provided by Section 132.062, on]
completion of training, the student is given a certificate by the
school or college indicating the program and that training was
satisfactorily completed.

SECTION 4. Section 132.062, Education Code, is repealed.

9 SECTION 5. This Act takes effect immediately if it receives 10 a vote of two-thirds of all the members elected to each house, as 11 provided by Section 39, Article III, Texas Constitution. If this 12 Act does not receive the vote necessary for immediate effect, this 13 Act takes effect September 1, 2019.
