- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Subchapter B, Chapter 469, Government Code, is
- 8 amended by adding Section 469.0585 to read as follows:
- 9 Sec. 469.0585. BUILDING CONSTRUCTION PERMITS AND FINAL
- 10 CERTIFICATES OF OCCUPANCY; ADMINISTRATIVE PENALTY. (a) The
- 11 commission shall impose an administrative penalty under Subchapter
- 12 F, Chapter 51, Occupations Code, on a political subdivision that
- 13 <u>issues a building construction permit or a final certificate of</u>
- 14 occupancy in violation of Section 469.102 or 469.105.
- 15 (b) Notwithstanding Section 51.302, Occupations Code, the
- 16 total amount of an administrative penalty under this section is the
- 17 amount calculated by multiplying the population of the political
- 18 subdivision by one cent.

- 19 (c) An administrative penalty collected under this section
- 20 may be appropriated only to the trusteed programs within the office
- 21 of the governor for the purpose of informing organizations and the
- 22 general public of disability issues.
- SECTION 2. Section 469.102(d), Government Code, is amended
- 24 to read as follows:

- 1 (d) A public official of a political subdivision who is
- 2 legally authorized to issue building construction permits may not
- 3 accept an application for a building construction permit for a
- 4 building or facility subject to Section 469.101 unless the
- 5 applicant submits verification to the official that:
- 6 (1) [official verifies that] the building or facility
- 7 has been registered with the department as provided by rule; and
- 8 (2) the plans and specifications for the building or
- 9 facility have been submitted to the department as required by
- 10 Subsection (c).
- 11 SECTION 3. Section 469.105, Government Code, is amended by
- 12 adding Subsection (c) to read as follows:
- 13 <u>(c) A political subdivision may not issue a final</u>
- 14 certificate of occupancy to the owner of a building or facility
- 15 described by Section 469.101 unless the owner provides to the
- 16 political subdivision a report or letter from a person or entity
- 17 described by Subsection (b) indicating that the building or
- 18 facility has been inspected by the person or entity and is in
- 19 compliance with the requirements of this chapter.
- SECTION 4. The changes in law made by this Act apply only to
- 21 a building or facility for which an application for a building
- 22 construction permit is submitted to a political subdivision on or
- 23 after the effective date of this Act. A building or facility for
- 24 which an application for a building construction permit is
- 25 submitted to a political subdivision before the effective date of
- 26 this Act is governed by the law in effect immediately before the
- 27 effective date of this Act, and that law is continued in effect for
