The changes in law made by this Act apply only to 2 a cause of action filed on or after the effective date of this Act. 3 A cause of action filed before the effective date of this Act is 4 governed by the law in effect immediately before the effective date 5 of this Act, and that law is continued in effect for that purpose. 6 SECTION 10.
