13	(a) The civil and political rights of a person who resides inside
14	the boundaries of Big Bend National Park or the Rio Grande Wild and
15	Scenic River are preserved and are not impaired by the operation of

- 20 Sec. 23.003. RETROCESSION OF CONCURRENT JURISDICTION. (a)
- 21 Simultaneously with the cession of concurrent jurisdiction under
- Section 23.051, the governor, on behalf of the state, shall accept 22
- from an authorized official of the National Park Service, United 23
- States Department of the Interior, a retrocession of concurrent 24

1 jurisdiction over territory that is: 2 (1) under exclusive federal jurisdiction; and 3 (2) in: (A) Big Bend National Park; or 4 5 (B) the Rio Grande Wild and Scenic River. (b) This section expires September 1, 2020, unless the 6 7 governor has received written acceptance of concurrent 8 jurisdiction under Section 23.051 by that date. 9 SECTION 3. Chapter 23, Parks and Wildlife Code, is amended 10 by adding Subchapter E to read as follows: SUBCHAPTER E. JURISDICTION 11 Sec. 23.051. CESSION OF CONCURRENT JURISDICTION. (a) The 12 governor, on behalf of the state, shall cede to the United States 13 14 concurrent jurisdiction over territory that: 15 (1) is owned by the United States within the boundaries of any unit of the national park system in this state; 16 17 and (2) is or would be, if not for this cession, under 18 19 proprietorial federal jurisdiction. (b) The cession of jurisdiction takes effect when an 20 authorized official of the National Park Service, United States 21

SECTION 4. (a) Not later than October 1, 2019, the governor

is received in the governor's office, the governor shall provide a

copy of the acceptance to the secretary of state. The secretary of

state shall publish the acceptance in the Texas Register.

(c) Not later than the 21st day after the written acceptance

- 10 this Act.
- 11 SECTION 5. This Act takes effect immediately if it receives
- 12 a vote of two-thirds of all the members elected to each house, as
- 13 provided by Section 39, Article III, Texas Constitution. If this
- 14 Act does not receive the vote necessary for immediate effect, this
- 15 Act takes effect September 1, 2019.
