19 (a) This section applies to a service plan under Section 43.065 [Before the first day of the 10th month after the month in 20 which the inventory is prepared as provided by Section 43.053, the 21 municipality proposing the annexation shall complete a service plan 22 that provides for the extension of full municipal services to the 23 24 area to be annexed. The municipality shall provide the services by any of the methods by which it extends the services to any other 25 26 area of the municipality].

(b) The service plan, which must be completed [in the period

provided by Subsection (a)] before the annexation, must include a 1 program under which the municipality will provide full municipal 2 3 services in the annexed area no later than 2-1/2 years after the effective date of the annexation, in accordance with Subsection 4 5 (e), unless certain services cannot reasonably be provided within that period and the municipality proposes a schedule for providing 6 those services, and must include a list of all services required by 7 8 this section to be provided under the plan. If the municipality proposes a schedule to extend the period for providing certain 9 10 services, the schedule must provide for the provision of full municipal services no later than 4-1/2 years after the effective 11 12 date of the annexation. However, under the program if the municipality provides any of the following services within the 13 14 corporate boundaries of the municipality before annexation, the 15 municipality must provide those services in the area proposed for annexation on the effective date of the annexation of the area: 16

2 (8) operation and maintenance of any other publicly 3 owned facility, building, or service.

The proposed service plan must be made available for (j) public inspection and explained to the inhabitants of the area at the public hearings held under Section <u>43.063</u> [43.0561]. The plan may be amended through negotiation at the hearings, but the provision of any service may not be deleted. On completion of the public hearings, the service plan shall be attached to the

10 ordinance annexing the area and approved as part of the ordinance. (k) On approval by the governing body, the service plan is a 11 12 contractual obligation that is not subject to amendment or repeal except that if the governing body determines at the public hearings 13 14 required by this subsection that changed conditions or subsequent 15 occurrences make the service plan unworkable or obsolete, the governing body may amend the service plan to conform to the changed 16 17 conditions or subsequent occurrences. An amended service plan must provide for services that are comparable to or better than those 18 established in the service plan before amendment. Before any 19 amendment is adopted, the governing body must 20 provide an opportunity for interested persons to be heard at public hearings 21 called and held in the manner provided by Section 43.063 [43.0561].

5 <u>(A) municipality, county, fire protection</u> 6 <u>service provider, including a volunteer fire department, and</u> 7 <u>emergency medical services provider, including a volunteer</u> 8 <u>emergency medical services provider; and</u>

9 (B) municipal utility district, water control 10 and improvement district, or other district created under Section 11 <u>52</u>, Article III, or Section <u>59</u>, Article XVI, Texas Constitution; 12 and

13 (3) each railroad company that serves the municipality 14 and is on the municipality's tax roll if the company's right-of-way 15 is in the area proposed for annexation.

SECTION 2.09. Section 43.0715(c), Local Government Code, is amended to read as follows:

(c) At the time notice of the municipality's intent to annex 18 19 the land within the district is first given in accordance with Section $[43.052_{7}]$ 43.0683 $[_{7}]$ or 43.0693, as applicable, the 20 municipality shall proceed to initiate and complete a report for 21 each developer conducted in accordance with the format approved by 22 23 the Texas Commission on Environmental Quality for audits. In the 24 event the municipality is unable to complete the report prior to the effective date of the annexation as a result of the developer's 25 26 failure to provide information to the municipality which cannot be obtained from other sources, the municipality shall obtain from the 27

1 district the estimated costs of each project previously undertaken by a developer which are eligible for reimbursement. 2 The amount of 3 such costs, as estimated by the district, shall be escrowed by the municipality for the benefit of the persons entitled to receive 4 5 payment in an insured interest-bearing account with a financial institution authorized to do business in the state. To compensate 6 the developer for the municipality's use of the infrastructure 7 8 facilities pending the determination of the reimbursement amount, all interest accrued on the escrowed funds shall be paid to the 9 10 developer whether or not the annexation is valid. Upon placement of the funds in the escrow account, the annexation may become 11 12 effective. In the event a municipality timely escrows all estimated reimbursable amounts as required by this subsection and 13 14 all such amounts, determined to be owed, including interest, are 15 subsequently disbursed to the developer within five days of final determination in immediately available funds as required by this 16 17 section, no penalties or interest shall accrue during the pendency of the escrow. Either the municipality or developer may, 18 by written notice to the other party, require disputes regarding the 19 amount owed under this section to be subject to nonbinding 20 21 arbitration in accordance with the rules of the American 22 Arbitration Association.

23 SECTION 2.10. Sections 43.0751(b) and (h), Local Government 24 Code, are amended to read as follows:

(b) The governing bodies of a municipality and a district may negotiate and enter into a written strategic partnership agreement for the district by mutual consent. [The governing body

1	of a municipality, on written request from a district included in
2	the municipality's annexation plan under Section 43.052, shall
3	negotiate and enter into a written strategic partnership agreement
4	with the district. A district included in a municipality's
5	annexation plan under Section 43.052:
6	[(1) may not submit its written request before the

On the full-purpose annexation conversion date set 11 (h) 12 forth in the strategic partnership agreement pursuant to Subsection (f)(5), the land included within the boundaries of the district 13 14 shall be deemed to be within the full-purpose boundary limits of the 15 municipality without the need for further action by the governing body of the municipality. The full-purpose annexation conversion 16 17 date established by a strategic partnership agreement may be altered only by mutual agreement of the district and 18 the 19 municipality. However, nothing herein shall prevent the 20 municipality from terminating the agreement and instituting proceedings to annex the district, on request by the governing body 21 of the district, on any date prior to the full-purpose annexation 22 23 conversion date established by the strategic partnership agreement 24 under the procedures prescribed by Subchapter C-1 [applicable to a tier 1 municipality]. 1 agreement, in which limited-purpose annexation is in effect; provide that, at the expiration of the period, the 2 (2) 3 district's annexation status will automatically revert to full-purpose annexation without following procedures provided by 4 Section [Sections] 43.014 [and 43.052 through 43.055] or any 5 [other] procedural requirement for annexation not in effect on 6 January 1, 1995; and 7 8 (3) specify the financial obligations of the district during and after the period of limited-purpose annexation for: 9 10 (A) facilities constructed by the municipality that are in or that serve the district; 11 debt incurred by the district for water and 12 (B) sewer infrastructure that will be assumed by the municipality at 13 14 the end of the period of limited-purpose annexation; and 15 (C) use of the municipal sales taxes collected by the municipality for facilities or services in the district. 16 SECTION 2.17. Section 43.905(a), Local Government Code, is 17 amended to read as follows: 18 19 (a) A municipality that proposes to annex an area shall provide written notice of the proposed annexation to each public 20 21 school district located in the area proposed for annexation within the period prescribed for providing the notice of the first hearing 22 under Section [43.0561,] 43.063, 43.0673, 43.0683, or 43.0693, as 23 24 applicable. SECTION 2.18. Sections 43.9051(a) and (b), Local Government 25 26 Code, are amended to read as follows: In this section, "public entity" includes a county, fire 27 (a)

1 protection service provider, including a volunteer fire 2 department, emergency medical services provider, including a 3 volunteer emergency medical services provider, or special district 4 <u>described</u>[, as that term is defined] by Section <u>43.062(b)(2)(B)</u> 5 [<u>43.052</u>].

6 (b) A municipality that proposes to annex an area shall 7 provide written notice of the proposed annexation within the period 8 prescribed for providing the notice of the first hearing under 9 Section [43.0561,] 43.063, 43.0673, 43.0683, or 43.0693, as 10 applicable, to each public entity that is located in or provides 11 services to the area proposed for annexation.

12 ARTICLE 3. T

ARTICLE 3. TRANSITION AND EFFECTIVE DATE

SECTION 3.01. The changes in law made by this Act apply only 13 14 to an annexation of an area that is not final on the effective date 15 of this Act. An annexation of an area that was final before the effective date of this Act is governed by those portions of Chapter 16 17 43, Local Government Code, that relate to post-annexation procedures and requirements in effect immediately before the 18 effective date of this Act, and that law is continued in effect for 19 that purpose. 20

SECTION 3.02. This Act takes effect September 1, 2019.
