Article 11.073(b), Code of Criminal Procedure, 5 is amended to read as follows: 6 7 (b) A court may grant a convicted person relief on an application for a writ of habeas corpus if: 8 9 (1) the convicted person files an application, in the manner provided by Article 11.07, 11.071, or 11.072, containing 10 11 specific facts indicating that: 12 (A) relevant scientific evidence is currently 13 available and was not available at the time of the convicted 14 person's trial because the evidence was not ascertainable through the exercise of reasonable diligence by the convicted person before 15 16 the date of or during the convicted person's trial; and (B) the scientific evidence would be admissible 17 18 under the Texas Rules of Evidence at a trial held on the date of the application; and 19 20 (2) the court makes the findings described by 21 Subdivisions (1)(A) and (B) and also finds that, had the scientific evidence been presented at trial, on the preponderance of the 22 23 evidence the person would not have been convicted or would have received a different punishment. 24

1 SECTION 2. Article 11.074, Code of Criminal Procedure, is 2 amended by amending Subsection (b) and adding Subsection (b-1) to 3 read as follows:

4 (b) If at any time the state represents to the convicting 5 court that an eligible indigent defendant under Article 1.051 has under a writ of habeas corpus a potentially meritorious claim for 6 relief from a judgment described by Subsection (a) [who was 7 8 sentenced or had a sentence suspended is not guilty, is guilty of only a lesser offense, or was convicted or sentenced under a law 9 10 that has been found unconstitutional by the court of criminal appeals or the United States Supreme Court], the court shall 11 appoint an attorney to investigate the claim and represent the 12 indigent defendant for purposes of filing an application for a writ 13 14 of habeas corpus, if an application has not been filed, or to otherwise represent the indigent defendant in a proceeding based on 15 the application for the writ. 16

17 (b-1) For purposes of Subsection (b), a potentially 18 meritorious claim is any claim the court determines is likely to 19 provide relief, including a claim that the defendant:

20	(1) is or may be actually innocent of the offense;
21	(2) is or may be guilty of only a lesser offense;
22	(3) was or may have been convicted or sentenced under a
23	law that has been found unconstitutional by the court of criminal
24	appeals or the United States Supreme Court; or
25	(4) was or may have been convicted or sentenced in
26	violation of the constitution of this state or the United States.
27	SECTION 3. Article 11.073, Code of Criminal Procedure, as

amended by this Act, applies only to an application for a writ of habeas corpus filed on or after the effective date of this Act. An application filed before the effective date of this Act is governed by the law in effect when the application was filed, and the former law is continued in effect for that purpose.

6 SECTION 4. The change in law made by this Act to Article 7 11.074, Code of Criminal Procedure, relating to an application 8 filed for a writ of habeas corpus applies regardless of whether the 9 offense for which the applicant is in custody was committed before, 10 on, or after the effective date of this Act.
