A BILL TO BE ENTITLED

AN ACT

2 relating to the extent of a defendant's criminal responsibility for
3 the conduct of a coconspirator in a capital murder case.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 7.02(b), Penal Code, is amended to read
6 as follows:

7 (b) If, in the attempt to carry out a conspiracy to commit
8 one felony, another felony is committed by one of the conspirators,
9 all conspirators are guilty of the felony actually committed,
10 though having no intent to commit it, provided that [~~if~~] the offense
11 was committed in furtherance of the unlawful purpose and was one
12 that should have been anticipated as a result of the carrying out of
13 the conspiracy. This subsection does not apply to the prosecution
14 of the offense of capital murder.

15 SECTION 2. The change in law made by this Act applies only
16 to the prosecution of an offense committed on or after the effective
17 date of this Act. The prosecution of an offense committed before the
18 effective date of this Act is governed by the law in effect on the
19 date the offense was committed, and the former law is continued in
20 effect for that purpose. For purposes of this section, an offense
21 was committed before the effective date of this Act if any element
22 of the offense occurred before that date.

23 SECTION 3. This Act takes effect September 1, 2019.
