Unless limited by court order or other provisions of this chapter, a nonparent, a licensed child-placing 18 19 agency, or the Department of Family and Protective Services appointed as a managing conservator of the child has the following 20 rights and duties: 21

(1) the right to have physical possession and to 22 23 direct the moral and religious training of the child;

24 (2) the duty of care, control, protection, and reasonable discipline of the child; 25

(11) if the parent-child relationship has been terminated with respect to the parents, or only living parent, or if there is no living parent, the right to consent to the adoption of the child and to make any other decision concerning the child that a parent could make; and
