In establishing the program, the commission shall build partnerships between military transition centers and local 13 14 workforce development boards to ensure the availability of employment services, including services related to: 15 16 (1) education; (2) career technical training; and 17 18 (3) entrepreneurship. The commission may award grants to state, local, or 19 private entities that perform activities related to the purposes of 20 21 this section. 22 (c) The commission shall administer the program using money 23 previously appropriated to the commission or received from federal

(d) The commission may adopt rules as necessary for the 1 2 administration of this section. Sec. 302.00335. TEXAS VETERANS LEADERSHIP PROGRAM. 3 The commission, in consultation with the Texas Veterans Commission, 4 5 shall establish a Texas Veterans Leadership Program. 6 (b) The mission of the program is to serve as a resource and 7 referral network connecting veterans with the resources and tools they need to lead productive lives and enjoy the full benefits of 8 the society they have willingly served. 9 (c) The program shall collaborate with local workforce 10 development boards to provide services to veterans under this 11 12 section. The program may collaborate with other federal, state, county, municipal, and private agencies to provide services to 13 14 veterans under this section. 15 (d) The program shall employ veterans to serve as veteran resource and referral specialists. A veteran resource and referral 16 17 specialist shall: 18 (1) seek out veterans in need of services; 19 (2) serve as a resource and referral agent, directing veterans to resources tailored to veterans' needs; 20 21 (3) make referrals and coordinate with other programs of the commission, the <u>Texas Veterans Commission</u>, and other 22 federal, state, county, municipal, and private agencies that 23 24 provide services for veterans relating to: 25 (A) employment;
