2	relating to a reemployment program available to certain veterans
3	placed on community supervision for a misdemeanor offense.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 42A, Code of Criminal Procedure, is
6	amended by adding Subchapter H-1 to read as follows:
7	SUBCHAPTER H-1. VETERANS REEMPLOYMENT PROGRAM
8	Art. 42A.381. VETERANS REEMPLOYMENT PROGRAM. In this
9	subchapter, "veterans reemployment program" means a program that
10	provides education and training to veterans with the goal that the
11	veterans obtain workforce skills and become gainfully employed.
12	Art. 42A.382. ELIGIBILITY. (a) A defendant placed on
13	community supervision, including deferred adjudication community
14	supervision, for a misdemeanor offense is eligible to participate
15	in a veterans reemployment program under this subchapter if the
16	defendant is a veteran of the United States armed forces, including
17	a member of the reserves, national guard, or state guard.
18	(b) The judge granting community supervision to a defendant
19	described by Subsection (a) shall inform the defendant of the
20	defendant's eligibility for participation in a veterans
21	reemployment program but may not require the defendant to
22	participate in the program.
23	(c) A judge may impose any condition of community

supervision that the judge is authorized to impose under this

- 2 under this subchapter, except that the judge may not impose a
- 3 condition related to the program or the defendant's participation
- 4 in the program.
- 5 Art. 42A.383. EDUCATION AND TRAINING COURSES. (a) The
- 6 program shall provide program participants with access to workforce
- 7 <u>development education and training courses developed or approved by</u>
- 8 the Texas Workforce Commission under Chapter 316, Labor Code.
- 9 (b) The education and training courses under this article
- 10 must focus on providing a participant with useful workplace skills
- 11 most likely to lead to gainful employment by the participant.
- 12 (c) The education and training courses may be
- 13 individualized based on any physical or intellectual limitations of
- 14 the participant.
- 15 Art. 42A.384. COMPLETION OF PROGRAM. A participant
- 16 successfully completes the veterans reemployment program if the
- 17 participant diligently attends and successfully completes the
- 18 education and training courses under Article 42A.383 and:
- 19 (1) obtains employment and retains that employment for
- 20 a continuous period of three months;
- 21 (2) diligently searches for employment for a
- 22 <u>continuous period of six months; or</u>
- 23 (3) is determined by the court to be unemployable
- 24 because of a disability.
- 25 Art. 42A.385. EXTENDED PERIOD ALLOWED FOR COMPLETION OF
- 26 PROGRAM. A defendant is not required to successfully complete a
- 27 program under this subchapter before the defendant completes the

- 1 applicable period of community supervision. The defendant may
- 2 continue to participate in a program following the defendant's
- 3 completion of that period.
- 4 Art. 42A.386. FAILURE TO COMPLETE PROGRAM. The judge may
- 5 not revoke the community supervision of a defendant solely because
- 6 the defendant fails to successfully complete a program under this
- 7 <u>subchapter.</u>
- 8 SECTION 2. Subchapter E-1, Chapter 411, Government Code, is
- 9 amended by adding Section 411.0729 to read as follows:
- Sec. 411.0729. PROCEDURE FOR CERTAIN VETERANS PLACED ON
- 11 COMMUNITY SUPERVISION. (a) On successful completion of the
- 12 veterans reemployment program under Subchapter H-1, Chapter 42A,
- 13 Code of Criminal Procedure, and all other conditions of the
- 14 <u>defendant's community supervision, including deferred adjudication</u>
- 15 community supervision, after notice to the state and a hearing on
- 16 whether issuance of an order of nondisclosure is in the best
- 17 interest of justice, the court shall enter an order of
- 18 nondisclosure with respect to all records of the offense for which
- 19 the defendant was placed on community supervision.
- 20 (b) Subsection (a) applies regardless of whether the
- 21 <u>defendant meets the other eligibility criteria under this</u>
- 22 subchapter.
- SECTION 3. Subtitle B, Title 4, Labor Code, is amended by
- 24 adding Chapter 316 to read as follows:
- 25 CHAPTER 316. VETERANS REEMPLOYMENT EDUCATION AND TRAINING COURSES
- Sec. 316.001. EDUCATION AND TRAINING COURSES. (a) The
- 27 commission shall develop or approve education and training courses

- 1 for the veterans reemployment program under Subchapter H-1, Chapter
- 2 42A, Code of Criminal Procedure, to assist eligible veterans in
- 3 obtaining workforce skills and becoming gainfully employed.
- 4 (b) The education and training courses must provide
- 5 instruction in workforce skills appropriate for veterans with
- 6 disabilities.
- 7 SECTION 4. Not later than January 1, 2020, the Texas
- 8 Workforce Commission shall develop or approve education and
- 9 training courses as required under Chapter 316, Labor Code, as
- 10 added by this Act.
- 11 SECTION 5. Subchapter H-1, Chapter 42A, Code of Criminal
- 12 Procedure, as added by this Act, applies only to a person placed on
- 13 community supervision, including deferred adjudication community
- 14 supervision, on or after January 1, 2020.
- 15 SECTION 6. This Act takes effect immediately if it receives
- 16 a vote of two-thirds of all the members elected to each house, as
- 17 provided by Section 39, Article III, Texas Constitution. If this
- 18 Act does not receive the vote necessary for immediate effect, this
- 19 Act takes effect September 1, 2019.
