4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter F, Chapter 51, Education Code, is
6	amended by adding Section 51.310 to read as follows:
7	Sec. 51.310. CULTURAL COMPETENCE AND IMPLICIT BIAS MEDICAL
8	EDUCATION COURSEWORK. (a) In this section:
9	(1) "Coordinating board" means the Texas Higher
10	Education Coordinating Board.
11	(2) "Cultural competence" and "implicit bias" have the
12	meanings assigned by Section 153.017, Occupations Code.
13	(3) "Medical school" has the meaning assigned by
14	<u>Section 61.501.</u>
15	(b) The coordinating board by rule shall require a medical
16	school to offer coursework in cultural competence and implicit bias
17	approved by the Texas Medical Board under Section 153.017(b),
18	Occupations Code.
19	(c) A medical school may not award a student a doctor of
20	medicine (M.D.) or doctor of osteopathic medicine (D.O.) degree
21	unless the student has successfully completed the number of hours
22	of coursework in cultural competence and implicit bias required by
23	coordinating board rule.
24	SECTION 2. Subchapter A, Chapter 153, Occupations Code, is

3	COMPETENCE AND IMPLICIT BIAS. (a) In this section:
4	(1) "Cultural competence" means, with respect to
5	health care, the ability to address the health issues of
6	individuals from diverse backgrounds effectively by applying
7	knowledge, empathy, and insight into the views on health that those
8	backgrounds present.
9	(2) "Implicit bias" means:
10	(A) bias in judgment or behavior that results
11	from subtle cognitive processes, including implicit attitudes and
12	stereotypes, that often operate at a level below conscious
13	awareness and without intentional control; or
14	(B) implicit attitudes and stereotypes that
15	result in beliefs or simple associations that a person makes
16	between an object and its evaluation that are automatically
17	activated by the mere presence, actual or symbolic, of the attitude
18	object.
19	(b) The board shall approve coursework and training in
20	cultural competence and implicit bias for purposes of Section
21	156.0011 of this code and Section 51.310(c), Education Code.
22	(c) Coursework and training approved under Subsection (b)
23	must be:
24	(1) designed to address medical decisions and
25	treatment relating to a person's race, ethnicity, nationality,
26	language, sex, gender, physical and mental ability, and
27	socioeconomic status; and

Subchapter A, Chapter 156, Occupations Code, is 8 amended by adding Section 156.0011 to read as follows: Sec. 156.0011. REQUIRED COURSEWORK OR TRAINING IN CULTURAL 9 COMPETENCE AND IMPLICIT BIAS; WAIVER. (a) In this section, 10 "cultural competence" and "implicit bias" have the meanings 11 12 assigned by Section 153.017. 13 (b) Except as provided by Subsection (d), the board may not issue a registration permit to or renew the registration permit of a 14 15 person unless the person has successfully completed: 16 (1) coursework in cultural competence and implicit 17 bias as a student in a doctor of medicine or doctor of osteopathic medicine degree program as required by Section 51.310, Education 18 19 Code; or (2) training in cultural competence and implicit bias 20 approved by the board under Section 153.017(b). 21 22 (c) A person who satisfies the requirements of Subsection (b) is not required to complete additional coursework or training 23 24 described by that subsection for the subsequent renewal of the 25 person's registration permit. 26 (d) The board by rule shall establish the minimum number of hours of training necessary to satisfy Subsection (b)(2). 1 license holder may complete the training as part of the hours of 2 continuing medical education completed to comply with Section 3 <u>156.051(a)(2).</u>

(e) The board may waive the requirements of this section for
a person who demonstrates in a manner prescribed by the board that
the person has successfully completed coursework or training that
is substantially equivalent to that approved by the board under
Section 153.017(b).

9 SECTION 4. Not later than December 1, 2019, the Texas Higher 10 Education Coordinating Board and the Texas Medical Board shall 11 adopt the rules necessary to implement this Act.

12 SECTION 5. (a) Section 51.310(c), Education Code, as added 13 by this Act, applies only to a student who enrolls in a doctor of 14 medicine (M.D.) or doctor of osteopathic medicine (D.O.) degree 15 program on or after January 1, 2020.

(b) Section 156.0011(b), Occupations Code, as added by this
Act, applies only to a registration permit issued or renewed on or
after January 1, 2020.

SECTION 6. This Act takes effect September 1, 2019.
