A BILL TO BE ENTITLED

1 AN ACT 2 relating to the use of public school counselors' work time. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 33.006, Education Code, is amended by 4 5 adding Subsections (d), (e), (f), and (g) to read as follows: 6 (d) Except as provided by Subsection (e), the board of trustees of each school district shall adopt a policy that requires 7 a school counselor to spend at least 80 percent of the school 8 9 counselor's total work time on duties that are components of a counseling program developed under Section 33.005. For purposes of 10 this subsection, time spent in administering assessment 11 instruments or providing other assistance in connection with 12 assessment instruments, except time spent in interpreting data from 13 14 assessment instruments, is not considered time spent on counseling. Each school in the district shall implement the policy. A copy of 15 16 the policy shall be maintained in the office of each school in the district and made available on request during regular school hours 17 to district employees, parents of district students, and the 18 public. 19 (e) If the board of trustees of a school district determines 20 that, because of staffing needs in the district or at a school in 21 the district, a school counselor must spend less than 80 percent of 22 23 the school counselor's total work time on duties that are components of a counseling program developed under Section 33.005, 24

- 1 the policy adopted under Subsection (d) shall:
- 2 (1) include the reasons why the counselor needs to
- 3 spend less than 80 percent of the counselor's work time on duties
- 4 that are components of the counseling program;
- 5 (2) list the duties the counselor is expected to
- 6 perform that are not components of the counseling program; and
- 7 (3) set the percentage of work time that the counselor
- 8 is required to spend on components of the counseling program.
- 9 (f) A school district may not include a provision in an
- 10 employment contract with a school counselor under Chapter 21 that
- 11 conflicts with the policy required by Subsection (d) or, except as
- 12 provided by Subsection (g), has the effect of authorizing a school
- 13 principal or school district superintendent to require a school
- 14 counselor to generally perform duties that are not primarily
- 15 <u>related to a counseling function.</u>
- 16 (g) A school district to which Subsection (e) applies may
- 17 not include a provision in an employment contract under Chapter 21
- 18 with an affected school counselor that has the effect of requiring
- 19 the counselor to generally perform a duty that is not primarily
- 20 related to a counseling function unless the duty is specified in the
- 21 district's policy under Subsection (e)(2).
- SECTION 2. Section 7.028(a), Education Code, is amended to
- 23 read as follows:
- 24 (a) Except as provided by Section 29.001(5), 29.010(a),
- 25 39.056(d-1), or 39.057, the agency may monitor compliance with
- 26 requirements applicable to a process or program provided by a
- 27 school district, campus, program, or school granted charters under

- 1 Chapter 12, including the process described by Subchapter F,
- 2 Chapter 11, or a program described by Subchapter B, C, D, E, F, H, or
- 3 I, Chapter 29, Subchapter A, Chapter 37, or Section 38.003, and the
- 4 use of funds provided for such a program under Subchapter C, Chapter
- 5 42, only as necessary to ensure:
- 6 (1) compliance with federal law and regulations;
- 7 (2) financial accountability, including compliance
- 8 with grant requirements; and
- 9 (3) data integrity for purposes of:
- 10 (A) the Public Education Information Management
- 11 System (PEIMS); and
- 12 (B) accountability under Chapters 39 and 39A.
- SECTION 3. Section 39.056, Education Code, is amended by
- 14 adding Subsection (d-1) to read as follows:
- 15 <u>(d-1)</u> Before a monitoring review, the commissioner shall
- 16 <u>request that the school district scheduled for the review assess</u>
- 17 the district's compliance with the policy adopted under Section
- 18 33.006(d) and provide a written copy of the assessment to the agency
- 19 on or before the date specified by the commissioner. As part of
- 20 each monitoring review, the agency shall interview a percentage of
- 21 <u>district school counselors determined by the commissioner to assess</u>
- 22 the district's compliance with the policy adopted under Section
- 23 33.006(d). The commissioner shall adopt rules to implement this
- 24 subsection.
- 25 SECTION 4. (a) Each school district shall implement a
- 26 policy adopted under Section 33.006(d), Education Code, as added by
- 27 this Act, beginning with the 2019-2020 school year.

- (b) Sections 33.006(f) and (g), Education Code, as added by this Act, apply only to a contract executed on or after the effective date of this Act. A contract executed before the date the contract was executed, and the former law is continued in effect for that purpose.
- 7 (c) Section 7.028(a), Education Code, as amended by this 8 Act, and Section 39.056(d-1), Education Code, as added by this Act, 9 apply beginning with the 2019-2020 school year.
- SECTION 5. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2019.
