- 12 SECTION 2. Article 12.03(d), Code of Criminal Procedure, is
- 13 amended to read as follows:
- 14 (d) Any [Except as otherwise provided by this chapter, any]
- 15 offense that bears the title "aggravated" shall carry the same
- 16 limitation period as the primary crime if a limitation period has
- 17 not otherwise been specifically provided for the aggravated offense
- 18 under another provision of this chapter.
- 19 SECTION 3. The change in law made by this Act does not apply
- 20 to an offense if the prosecution of that offense becomes barred by
- 21 limitation before the effective date of this Act. The prosecution
- 22 of that offense remains barred as if this Act had not taken effect.
- 23 SECTION 4. This Act takes effect September 1, 2019.
