relating to the provision of notice by the Texas Ethics Commission.
BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
SECTION 1. Subchapter B, Chapter 571, Government Code, is
amended by adding Section 571.033 to read as follows:
Sec. 571.033. NOTIFICATION PROCEDURES. (a) Except as
provided by Subsection (b), the commission may adopt rules
prescribing how the commission will notify any person or provide
any notice required by this subtitle, Chapter 305, or Title 15,
Election Code.
(b) Subsection (a) does not authorize the commission to
adopt rules prescribing how the commission will notify any person
or provide any notice required by Subchapter E or F of this chapter
or how the commission will issue a warning of liability under
Section 254.042(b), Election Code.
SECTION 2. The heading to Section 572.030, Government Code,

  5 commission shall mail a copy of the financial statement forms and
  6 instructions to an individual not later than the third business day
  7 after the date the commission receives the individual's request for
  8 the forms and instructions.
- 9 SECTION 4. This Act takes effect September 1, 2019.
