## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the inclusion of satisfactory performance on certain
3	postsecondary readiness assessment instruments in the indicators
4	for evaluating the performance of public schools.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Section 39.0238(f), Education Code, is amended
7	to read as follows:
8	(f) The results of a postsecondary readiness assessment
9	instrument administered under this section may not be used by:
10	(1) [the agency for accountability purposes for a
11	school campus or school district;
12	[ <del>(2)</del> ] a school district:
13	(A) for the purpose of teacher evaluations; or
14	(B) in determining a student's final course grade
15	or determining a student's class rank for the purpose of high school
16	graduation; or
17	(2) [ $(3)$ ] an institution of higher education:
18	(A) for admission purposes; or
19	(B) to determine eligibility for a TEXAS grant.
20	SECTION 2. Section 39.053(c), Education Code, as amended by
21	Chapters 807 (H.B. 22), 842 (H.B. 2223), and 1088 (H.B. 3593), Acts
22	of the 85th Legislature, Regular Session, 2017, is reenacted and
23	amended to read as follows:
24	(c) School districts and campuses must be evaluated based on

- 25 39.023(b), as applicable for the district and campus, including the
- 26 percentage of students who performed satisfactorily on the
- 27 assessment instruments, as determined by the performance standard

- 5 indicators that account for:
- 6 (i) students who satisfy the Texas Success

- 8 Texas Higher Education Coordinating Board under Section 51.334 on
- 9 an assessment instrument in reading or mathematics designated by

- 1 (viii) students who successfully met 2 standards on a composite of indicators that through research
- 3 indicates the student's preparation to enroll and succeed, without
- 4 remediation, in an entry-level general education course for a
- 5 baccalaureate degree or associate degree;
- 6 (ix) high school graduation rates, computed
- 7 in accordance with standards and definitions adopted in compliance
- 8 with the Every Student Succeeds Act (20 U.S.C. Section 6301 et seq.)
- 9 subject to the exclusions provided by Subsections (g), (g-1),
- 10 (g-2), and (g-3);
- 11 (x) students who successfully completed an
- 12 OnRamps dual enrollment course; [and]
- 13 (xi) [the percentage of] students who
- 14 successfully completed a practicum or internship approved by the
- 15 State Board of Education;
- 16 <u>(xii)</u> students who are awarded an <u>associate</u>
- 17 [associate's] degree; and
- 18 (xiii) students who satisfy the relevant
- 19 performance standards on an Algebra II or English III postsecondary
- 20 readiness assessment instrument administered under Section
- 21 39.0238;
- 22 (2) in the school progress domain, indicators for
- 23 effectiveness in promoting student learning, which must include:
- (A) for assessment instruments, including
- 25 assessment instruments under Subdivisions (1)(A)(i) and (ii), the
- 26 percentage of students who met the standard for improvement, as
- 27 determined by the commissioner; and

- 1 (B) for evaluating relative performance, the
- 2 performance of districts and campuses compared to similar districts
- 3 or campuses; and
- 4 (3) in the closing the gaps domain, the use of
- 5 disaggregated data to demonstrate the differentials among students
- 6 from different racial and ethnic groups, socioeconomic
- 7 backgrounds, and other factors, including:
- 8 (A) students formerly receiving special
- 9 education services;
- 10 (B) students continuously enrolled; and
- 11 (C) students who are mobile.
- 12 SECTION 3. To the extent of any conflict, this Act prevails
- 13 over another Act of the 86th Legislature, Regular Session, 2019,
- 14 relating to nonsubstantive additions to and corrections in enacted
- 15 codes.
- SECTION 4. This Act applies beginning with the 2019-2020
- 17 school year.
- SECTION 5. This Act takes effect immediately if it receives
- 19 a vote of two-thirds of all the members elected to each house, as
- 20 provided by Section 39, Article III, Texas Constitution. If this
- 21 Act does not receive the vote necessary for immediate effect, this
- 22 Act takes effect September 1, 2019.
