(a) Not later than the 30th day [As 1-28 soon as practicable] after the date of the death of an individual 1-29 listed under Section 615.003 that <u>occurs in the performance of</u> duties in the individual's position as described by Section 615.003 or as a result of an action that occurs while the individual is 1-30 1-31 1-32 performing those duties [is claimed to meet the requirements 1-33 of Section 615.021(1)], the individual's employing entity shall 1-34 1-35 furnish to the board of trustees of the Employees Retirement System 1-36 of Texas proof of the death in the form and with additional evidence and information required by the board.
