- 5 SECTION 1. Section 37.0812, Education Code, is amended to

- 7 Sec. 37.0812. TRAINING POLICY: SCHOOL DISTRICT PEACE
- 8 OFFICERS AND SCHOOL RESOURCE OFFICERS. A school district [with an
- 9 enrollment of 30,000 or more students] that commissions a school
- 10 district peace officer or at which a school resource officer
- 11 provides law enforcement shall adopt a policy requiring the officer
- 12 to complete the education and training program required by Section
- 13 1701.263, Occupations Code.
- 14 SECTION 2. Section 1701.263(b), Occupations Code, is
- 15 amended to read as follows:
- 16 (b) The commission by rule shall require a school district
- 17 peace officer or a school resource officer who is commissioned by or
- 18 who provides law enforcement at a school district [$\frac{\text{with an}}{\text{c}}$]
- 19 enrollment of 30,000 or more students] to successfully complete an

- 1 (3) provide training in accordance with the curriculum 2 developed under Section 1701.262 in each subject area listed in 3 Subsection (c) of that section.
- 4 SECTION 3. (a) Notwithstanding Section 1701.263(b), 5 Occupations Code, as amended by this Act, a school district peace officer or school resource officer who commences employment with or 6 commences providing law enforcement at a school district with an 7 8 enrollment of fewer than 30,000 students on a date occurring before September 1, 2019, shall complete the training required by Section 9 1701.263, Occupations Code, as amended by this Act, as soon as 10 practicable and not later than August 31, 2020. This subsection 11 does not apply to an officer who is exempt from the training 12 established under Section 1701.263, Occupations Code, as amended by 13 14 this Act, because the officer has completed the training described 15 by Subsection (b-1) of that section.
- (b) Not later than October 1, 2019, a school district with an enrollment of fewer than 30,000 students shall adopt the training policy for school district peace officers and school resource officers required by Section 37.0812, Education Code, as amended by this Act.
- 21 SECTION 4. This Act takes effect September 1, 2019.
