9	(a) A speaker candidate or former speaker candidate commits

11	(1) knowingly fails to file the declaration of
12	candidacy required by Section 302.0121;
13	(2) knowingly fails to file the statement required by
14	Section 302.013;
15	(3) knowingly accepts a contribution, loan, or promise
16	of a contribution or loan in violation of Section 302.0121(c);
17	(4) [knowingly accepts a contribution, loan, or
18	promise of a contribution or loan prohibited by Section 302.017
19	from a corporation, partnership, association, firm, union,
20	foundation, committee, club, or other organization or group of
21	persons;
22	[(5)] knowingly accepts a contribution from a person
23	who uses political contributions, interest earned on political
24	contributions, or an asset purchased with political contributions

1 to make the contribution in violation of Section 302.0191;

2 (5) [(6)] expends campaign funds for any purpose other
3 than those enumerated in Section 302.020;

4 (6) [(7)] knowingly retains contributions, assets
5 purchased with contributions, or interest or other income earned on
6 contributions in violation of Section 302.0201(b); or

7 (7) [(8)] knowingly fails to file the report of 8 unexpended campaign funds as required by Section 302.0201(d).

9 SECTION 3. This Act takes effect immediately if it receives 10 a vote of two-thirds of all the members elected to each house, as 11 provided by Section 39, Article III, Texas Constitution. If this 12 Act does not receive the vote necessary for immediate effect, this 13 Act takes effect September 1, 2019.
