## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to eligibility requirements for student loan repayment
- 3 assistance for certain mental health professionals.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 61.603, Education Code, is amended to
- 6 read as follows:
- 7 Sec. 61.603. ELIGIBILITY. (a) Except as provided by
- 8 Subsection (b), to [To] be eligible to receive repayment assistance
- 9 under this subchapter, a mental health professional must:
- 10 (1) apply to the board;
- 11 (2) have completed one, two, three, four, or five
- 12 consecutive years of practice in a mental health professional
- 13 shortage area designated by the Department of State Health
- 14 Services; and
- 15 (3) provide mental health services in this state to:
- 16 (A) recipients under the medical assistance
- 17 program authorized by Chapter 32, Human Resources Code;
- 18 (B) enrollees under the child health plan program
- 19 authorized by Chapter 62, Health and Safety Code; or
- 20 (C) persons committed to a secure correctional
- 21 facility operated by or under contract with the Texas Juvenile
- 22 Justice Department or persons confined in a secure correctional
- 23 facility operated by or under contract with any division of the
- 24 Texas Department of Criminal Justice.

- 1 (b) To be eligible to receive repayment assistance under
- 2 this subchapter, a mental health professional described by Section
- 3 <u>61.601(1)</u> who specializes in the diagnosis and treatment of
- 4 psychiatric and associated behavioral health issues affecting
- 5 children must:
- 6 (1) apply to the board;
- 7 (2) provide mental health services to children in this
- 8 state; and
- 9 (3) have completed one, two, three, four, or five
- 10 consecutive years of practice in this state as described by
- 11 Subdivision (2), including a practice that consists solely of the
- 12 remote diagnosis and treatment of children.
- 13 (c) In addition to satisfying the requirements under
- 14 Subsection (a) or (b), as applicable, for a licensed physician to be
- 15 eligible to receive repayment assistance under this subchapter
- 16 after the physician's third consecutive year of practice described
- 17 under Subsection (a)(2) or (b), as applicable, the physician must
- 18 be certified in psychiatry by:
- 19 (1) the American Board of Psychiatry and Neurology; or
- 20 (2) the American Osteopathic Board of Neurology and
- 21 Psychiatry.
- 22 SECTION 2. The change in law made by this Act to Section
- 23 61.603, Education Code, applies only to a person who first
- 24 establishes eligibility for loan repayment assistance under
- 25 Subchapter K, Chapter 61, Education Code, as amended by this Act, on
- 26 the basis of an application submitted on or after September 1, 2019.
- 27 A person who first establishes eligibility on the basis of an

- 1 application submitted before September 1, 2019, is governed by the
- 2 law in effect on the date the application was submitted, and the
- 3 former law is continued in effect for that purpose.
- 4 SECTION 3. This Act takes effect September 1, 2019.
