4	(c) Not less than 50 percent of money used from the state
5	participation account of the development fund in any fiscal year

8	SECTION 4. Subchapter E, Chapter 16, Water Code, is amended
9	by adding Sections 16.145 and 16.146 to read as follows:
10	Sec. 16.145. INTERREGIONAL WATER SUPPLY PROJECTS. (a) The
11	board shall identify, establish selection criteria for, and issue a
12	request for proposals for water supply projects that benefit
13	multiple water planning regions. Selection criteria established
14	under this section must prioritize projects that:
15	(1) maximize the use of private financial resources;
16	(2) combine the financial resources of multiple water
17	planning regions; and
18	(3) have a substantial economic benefit to the regions

23	needs of the water users served by the project.
24	(b) The board and the commission shall enter into a
25	memorandum of understanding for the expedited approval of permits

ACCOUNT II. (a) The board may use the state participation account II created under Section 17.957 to provide financial assistance for the development of a desalination or aquifer storage and recovery facility, including associated intake or distribution facilities, to meet existing or projected future water needs by acquiring such a facility or an ownership interest in such a facility.

7 (b) The board may act singly or in a joint venture in partnership with any person, including a public or private entity, 8 an agency or political subdivision of this state, another state or a 9 political subdivision of another state, the United States, or a 10 foreign nation, to the extent permitted by law. The board may 11 12 provide financial assistance under this section for a facility without regard to any requirements provided by board rules 13 14 regarding the portion of the capacity of the facility that will 15 serve an existing need or the portion of the cost of the facility that the applicant will finance from sources other than the state 16 17 participation account II.

18 (c) Section 16.135 does not apply to the use of the state 19 participation account II to develop a facility described by 20 Subsection (a) of this section by acquiring the facility or an 21 interest in the facility.

22 (d) Before the board may acquire a facility or an interest 23 in a facility described by Subsection (a), the board must find 24 <u>affirmatively that:</u> 25 (1) it is reasonable to expect that the state will

26 recover its investment in the facility; and

27 (2) the public interest will be served by the

1	acquisition of the facility.
2	(e) The board may not provide financial assistance under
3	this section for a facility unless the facility is included in the
4	state water plan.
5	(f) The board shall establish a point system for
6	prioritizing facilities for which financial assistance is sought
7	from the board under this section. The system must include a
8	standard for the board to apply in determining whether a facility
9	qualifies for financial assistance at the time the application for
10	financial assistance is filed with the board.
11	(g) The board may not issue more than \$200 million in water
12	financial assistance bonds designated by the board as issued to
13	provide financial assistance for facilities under this section.
14	(h) If the board does not provide financial assistance for a
15	facility under this section from the state participation account II
16	before September 1, 2024, the board may not provide financial
17	assistance for any facility from that account after that date.
18	SECTION 5. Section 16.182, Water Code, is amended to read as
19	follows:
20	Sec. 16.182. <u>PERMITS</u> [PERMIT] REQUIRED. <u>(a)</u> Before the
21	board grants the application to buy, receive, or lease the
22	facilities, the applicant shall first secure <u>all appropriate</u>
23	permits [a permit for water use] from the commission. If the
24	facilities are to be leased, <u>a</u> [the] permit may be for a term of
25	years.
26	(b) The board may assist the applicant with securing permits
27	for a facility described by Section 16.146.

1 SECTION 6. Section 17.957, Water Code, is amended by 2 amending Subsections (b) and (c) and adding Subsection (c-1) to 3 read as follows:

(b) The state participation account is composed of:

(1) money and assets attributable to water financial
assistance bonds designated by the board as issued for projects
described in <u>Sections</u> [Section] 16.131 and 16.146;

money from the sale, transfer, or lease of a 8 (2) Subdivision project described in (1)that 9 was acquired, 10 constructed, reconstructed, developed, or enlarged with money from the state participation account; 11

12 (3) payments received under a bond enhancement 13 agreement with respect to water financial assistance bonds 14 designated by the board as issued for projects described in 15 <u>Sections</u> [Section] 16.131 and 16.146;

16 (4) investment income earned on money on deposit in 17 the state participation account;

18 (5) money disbursed to the fund from the state water
19 implementation fund for Texas as authorized by Section 15.434; and

20 (6) any other funds, regardless of their source, that 21 the board directs be deposited to the credit of the state 22 participation account.

(c) Money on deposit in the state participation account may
be used by the board for projects described in <u>Sections</u> [Section]
16.131 and 16.146 in the manner that the board determines necessary
for the administration of the fund.
