## A BILL TO BE ENTITLED

1 AN ACT 2 relating to the establishment of a rural resident physician grant 3 program. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. Chapter 58A, Education Code, is amended by adding Subchapter E to read as follows: 6 7 SUBCHAPTER E. RURAL RESIDENT PHYSICIAN GRANT PROGRAM Sec. 58A.081. RURAL RESIDENT PHYSICIAN GRANT PROGRAM. (a) 8 The board shall administer the Rural Resident Physician Grant 9 Program as a competitive grant program to encourage the creation of 10 new graduate medical education positions in rural and 11 nonmetropolitan areas, with particular emphasis on the creation of 12 rural training tracks. The board shall award grants to new or 13 14 expanded physician residency programs at teaching hospitals and other appropriate health care entities according to the program 15 16 criteria established under this section. (b) The board shall establish criteria for the grant program 17 in consultation with one or more physicians, including a physician 18 who practices in a rural area of this state, teaching hospitals, 19 medical schools, and independent physician residency programs, and 20 with other persons considered appropriate by the board. 21 The

22 program criteria must take into account whether a rural or 23 nonmetropolitan area has the resources sufficient to support a 24 physician residency program in a manner that would satisfy

1 applicable residency program accreditation requirements. 2 (c) The board may provide grants only to support a physician 3 residency program: 4 (1) that provides the level of medical care that is 5 most needed in a rural or nonmetropolitan area; and 6 (2) until the program becomes eligible for federal 7 grant funding. 8 (d) Grant funds awarded under this section may be used only to pay direct costs associated with creating or maintaining a 9 residency position, including the salary of the resident physician. 10 11 (e) Each grant application must: 12 (1) specify the number of residency positions expected to be created or maintained with the grant money; 13 14 (2) specify the grant amount requested for each year; 15 (3) include documentation of infrastructure and staffing to satisfy applicable residency program accreditation 16 17 requirements; (4) include documentation that the residency program 18 19 will set a primary goal of producing physicians who are prepared for practice in a rural area; and 20 21 (5) include evidence of support for residency training 22 by sponsoring institutions and the community. (f) The board shall award grants for all residency positions 23 24 awarded a grant under this section in the preceding year before awarding a grant for a residency position that did not receive a 25 26 grant in the preceding year, provided that the applicable grant recipient from the preceding year complies with all conditions of 27

the grant as described by Subsection (g) and satisfies the grant eligibility requirements. (g) The board shall monitor physician residency programs receiving grants as necessary to ensure compliance with the grant program and shall require the return of any unused grant money by, or shall decline to award additional grants to, a residency program that receives a grant but fails to: (1) create and fill, within a reasonable period, the number of residency positions proposed in the program's grant application; or (2) satisfy any other conditions of the grant imposed by the board. (h) The board shall use money forfeited under Subsection (g) to award grants to other eligible applicants. With respect to the physician residency program forfeiting the grant, the board may restore grant money or award additional grants, as applicable, to the program as soon as practicable after the program satisfies all

9 SECTION 2. (a) As soon as practicable after the effective 10 date of this Act, the Texas Higher Education Coordinating Board 11 shall adopt rules for the implementation and administration of the 12 grant program established under Subchapter E, Chapter 58A, 13 Education Code, as added by this Act. The board may adopt the 14 initial rules in the manner provided by law for emergency rules.

(b) Not later than October 1, 2019, the Texas Higher Education Coordinating Board shall establish the grant program required by Subchapter E, Chapter 58A, Education Code, as added by this Act, and shall begin to award grants under that program not later than January 1, 2020.

20 SECTION 3. This Act takes effect immediately if it receives 21 a vote of two-thirds of all the members elected to each house, as 22 provided by Section 39, Article III, Texas Constitution. If this 23 Act does not receive the vote necessary for immediate effect, this 24 Act takes effect September 1, 2019.
