- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 1001.205, Health and Safety Code, is
- 6 amended to read as follows:
- 7 Sec. 1001.205. REPORTS. (a) Not later than September 30 of
- 8 each year, a local mental health authority shall provide to the
- 9 department the number of:
- 10 (1) employees and contractors of the authority who
- 11 were trained as mental health first aid trainers under Section
- 12 1001.202 during the preceding fiscal year, the number of trainers
- 13 who left the program for any reason during the preceding fiscal
- 14 year, and the number of active trainers;
- 15 (2) university employees, school district employees,
- 16 and school resource officers who completed a mental health first
- 17 aid training program offered by the authority under Section
- 18 1001.203 during the preceding fiscal year <u>categorized by local</u>
- 19 mental health authority region, school district, and category of
- 20 personnel; and
- 21 (3) individuals who are not university employees,
- 22 school district employees, or school resource officers who
- 23 completed a mental health first aid training program offered by the
- 24 authority during the preceding fiscal year.

- 1 (b) Not later than December 1 of each year, the department
- 2 shall compile the information submitted by local mental health
- 3 authorities as required by Subsection (a) and submit a report to the
- 4 legislature containing [the number of]:
- 5 (1) the number of authority employees and contractors
- 6 trained as mental health first aid trainers during the preceding
- 7 fiscal year, the number of trainers who left the program for any
- 8 reason during the preceding fiscal year, and the number of active
- 9 trainers;
- 10 (2) the number of university employees, school
- 11 district employees, and school resource officers who completed a
- 12 mental health first aid training program provided by an authority
- 13 during the preceding fiscal year categorized by local mental health
- 14 authority region, school district, and category of personnel; [and]
- 15 (3) the number of individuals who are not university
- 16 employees, school district employees, or school resource officers
- 17 who completed a mental health first aid training program provided
- 18 by an authority during the preceding fiscal year; and
- 19 <u>(4) a detailed accounting of expenditures of money</u>
- 20 appropriated for the purpose of implementing this subchapter.
- 21 SECTION 2. (a) Section 1001.205(a), Health and Safety
- 22 Code, as amended by this Act, applies only to a report due under
- 23 that subsection after September 30, 2019. A report due under that
- 24 subsection before that date is governed by the law in effect
- 25 immediately before the effective date of this Act, and that law is
- 26 continued in effect for that purpose.
- 27 (b) Section 1001.205(b), Health and Safety Code, as amended
