WAIVER OF CERTAIN FEES FOR CERTAIN 8 APPLICANTS WHO HOLD CARDIOPULMONARY RESUSCITATION CERTIFICATION. 9 (a) Notwithstanding any other provision of this subchapter, the 10 department shall waive any fee required for the issuance of an 11 original or renewed license under this subchapter if at the time of 12 the application the applicant for the license submits to the 13 14 department satisfactory evidence that the applicant: 15 (1) holds a current certification in cardiopulmonary 16 resuscitation issued by the American Heart Association, the American Red Cross, or another nationally recognized association; 17 18 and (2) is not required to hold the certification 19 described by Subdivision (1) as a condition of obtaining or 20 maintaining employment or an occupational license. 21 (b) For purposes of Subsection (a)(2), "occupational 22 23 license" means a license, certificate, registration, permit, or

WAIVER OF CERTAIN FEES FOR CERTAIN 5 APPLICANTS WHO HOLD CARDIOPULMONARY RESUSCITATION CERTIFICATION. (a) A person is exempt from the payment of any fee for the issuance 6 of an original or renewal driver's license, as provided under this 7 8 chapter, if at the time of the application for an original or renewal driver's license the person submits to the department 9 10 satisfactory evidence that the person: (1) holds a current certification in cardiopulmonary 11 12 resuscitation issued by the American Heart Association, the American Red Cross, or another nationally recognized association; 13 14 and 15 (2) is not required to hold the certification described by Subdivision (1) as a condition of obtaining or 16 17 maintaining employment or an occupational license. (b) For purposes of Subsection (a)(2), "occupational 18 license" means a license, certificate, registration, permit, or 19

20 other form of authorization that a person must obtain to practice or 21 engage in a particular business, occupation, or profession.

SECTION 3. (a) Section 411.1954, Government Code, as added by this Act, applies only to an application for an original or renewed license to carry a handgun submitted on or after the effective date of this Act. An application submitted before the effective date of this Act is governed by the law in effect when the application was submitted, and the former law is continued in

1 effect for that purpose.

(b) Section 521.1812, Transportation Code, as added by this Act, applies only to an application for an original or renewal driver's license submitted on or after the effective date of this Act. An application submitted before the effective date of this Act is governed by the law in effect when the application was submitted, and the former law is continued in effect for that purpose.
