BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subchapter D, Chapter 801, Occupations Code, is amended by adding Section 801.165 to read as follows:

Sec. 801.165. PEACE OFFICERS. (a) The board may employ and commission as a peace officer to enforce this chapter a person who has been certified as qualified to be a peace officer by the Texas Commission on Law Enforcement.

(b) If the board commissions peace officers under Subsection (a), the board shall designate a peace officer as the chief investigator to supervise and direct the other peace officers commissioned by the board. The chief investigator must have appropriate training and experience in law enforcement, determined by the board.

SECTION 2. Article 2.12, Code of Criminal Procedure, amended to read as follows:

WHO ARE PEACE OFFICERS. The following are peace Art. 2.12. officers:

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2019.
