A BILL TO BE ENTITLED

- 2 relating to the hours for the sale or delivery of certain alcoholic
- 3 beverages.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 24.07, Alcoholic Beverage Code, is
- 6 amended to read as follows:
- 7 Sec. 24.07. WHEN LICENSE ALSO HELD: HOURS OF SALE, ETC. A
- 8 holder of a wine only package store permit who also holds a retail
- 9 dealer's off-premise license for the same location may remain open
- 10 and sell ale, wine, vinous liquors, and beer, for off-premises
- 11 consumption only, on any day and during the same hours that the
- 12 holder of a wine and beer retailer's permit may sell ale, beer, and
- 13 wine, except that the permit holder [he] may not sell wine or vinous
- 14 liquor containing more than 17 percent alcohol by volume [on a
- 15 Sunday or] after 10 p.m. on any day.
- 16 SECTION 2. Section 105.01, Alcoholic Beverage Code, is
- 17 amended to read as follows:
- 18 Sec. 105.01. HOURS OF SALE: LIQUOR. $[\frac{a}{a}]$ Except as
- 19 provided in Sections 105.02, 105.03, 105.04, and 105.08, no person
- 20 may sell, offer for sale, or deliver any liquor:
- 21 (1) on New Year's Day, Thanksgiving Day, or Christmas
- 22 Day;
- 23 (2) before noon or after 10 p.m. on Sunday; or
- 24 (3) before 9 [$\frac{10}{10}$] a.m. or after 10 [$\frac{9}{10}$] p.m. on any

- 1 other day.
- 2 [(b) When Christmas Day or New Year's Day falls on a Sunday,
- 3 Subsection (a) of this section applies to the following Monday.
- 4 SECTION 3. Section 105.02, Alcoholic Beverage Code, is
- 5 amended to read as follows:
- 6 Sec. 105.02. HOURS OF SALE: WHOLESALERS AND LOCAL
- 7 DISTRIBUTORS TO RETAILERS. (a) A holder of a wholesaler's permit
- 8 may sell, offer for sale, or deliver liquor to a retailer anytime
- 9 except [Sunday and] Christmas Day.
- 10 (b) A local distributor's permittee may sell, offer for
- 11 sale, or deliver liquor to a retailer between 5 a.m. and 9 p.m. on
- 12 any day except:
- 13 (1) [Sunday;
- 14 $\left[\frac{(2)}{2}\right]$ Christmas Day; or
- 15 $\underline{(2)}$ [$\overline{(3)}$] a day on which a package store permittee is
- 16 prohibited from selling liquor.
- 17 SECTION 4. This Act takes effect September 1, 2019.
