- 2 facility or residential placement facility to pay for the education
- 3 services provided to the student; or
- 4 (2) the district does not receive sufficient funds,
- 5 including state funds provided under Sections 42.151 and 42.152 and
- 6 federal funds, for all students in the district residing in care and
- 7 treatment facilities or residential placement facilities to pay for
- 8 the education services provided to the students.
- 9 (d) A school district that applies for a grant under this
- 10 <u>section must provide the commissioner with a report comparing the</u>
- 11 state and federal funds received by the district for students
- 12 residing in care and treatment facilities and residential placement
- 13 facilities with the expenses incurred by the district in providing

- (e) Expenses that may be included by a school district in
