## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the establishment of the private child care task force.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. (a) In this section, "task force" means the
- 5 private child care task force.
- 6 (b) The private child care task force is established to
- 7 study private child care providers in this state and methods to
- 8 reduce the amounts charged for and increase the availability of
- 9 child care provided by private child care providers.
- 10 (c) The task force is composed of seven members appointed as
- 11 follows:
- 12 (1) one member appointed by the governor to represent
- 13 the governor;
- 14 (2) three members of the senate, appointed by the
- 15 lieutenant governor; and
- 16 (3) three members of the house of representatives,
- 17 appointed by the speaker of the house of representatives.
- 18 (d) A task force member is not entitled to compensation for
- 19 service on the task force but is entitled to reimbursement for
- 20 actual and necessary expenses incurred in performing task force
- 21 duties. The task force may accept gifts, grants, and donations to
- 22 pay for those expenses.
- (e) The member appointed by the governor shall serve as the
- 24 presiding officer of the task force.

- 1 (f) The task force shall meet at least quarterly at the call 2 of the presiding officer.
- 3 (g) Notwithstanding Chapter 551, Government Code, or any 4 other law, the task force may meet by telephone conference call,
- 5 videoconference, or other similar telecommunication method. A
- 6 meeting held by telephone conference call, videoconference, or
- 7 other similar telecommunication method is subject to the
- 8 requirements of Sections 551.125(c), (d), (e), and (f), Government
- 9 Code.
- 10 (h) The task force shall conduct a study to examine the
- 11 amounts charged for and the availability of child care provided by
- 12 private child care providers and methods to reduce those costs and
- 13 increase the availability of that care. The task force may request
- 14 relevant information from the Health and Human Services Commission,
- 15 and the commission shall comply with the request.
- 16 (i) The task force shall develop recommendations to reduce
- 17 the amounts charged for and increase the availability of child care
- 18 by private child care providers.
- 19 (j) The task force shall develop and submit a written report
- 20 on the study and recommendations developed by the task force to the
- 21 governor, the lieutenant governor, the speaker of the house of
- 22 representatives, and each member of the legislature not later than
- 23 November 1, 2020.
- (k) The task force is abolished and this Act expires June 1,
- 25 2021.
- 26 SECTION 2. This Act takes effect immediately if it receives
- 27 a vote of two-thirds of all the members elected to each house, as

- 1 provided by Section 39, Article III, Texas Constitution. If this
- 2 Act does not receive the vote necessary for immediate effect, this
- 3 Act takes effect September 1, 2019.
