6	Code, is amended by adding Sections 501.1031 and 501.108 to read as

8	Sec. 501.1031. CERTAIN GENERAL INFRASTRUCTURE PROJECTS. In
9	this subtitle, "project" includes expenditures that are found by
10	the board of directors to be suitable for general infrastructure,
11	limited to the development, improvement, maintenance, or expansion
12	<pre>of:</pre>
13	(1) streets and roads;
14	(2) water supply facilities; or
15	(3) sewage facilities.
16	Sec. 501.108. PROJECTS RELATED TO PUBLIC SAFETY. (a) In
17	this subtitle, "project" includes expenditures that are found by
18	the board of directors to be required or suitable for improving,
19	enhancing, or supporting public safety, including:
20	(1) expenditures for improving public safety
21	<pre>facilities;</pre>
22	(2) expenditures for public safety equipment and for
23	first responders and other personnel; and
24	(3) other expenditures that enhance the level of

- 2 (b) For purposes of this section, "first responder" has the
- 3 meaning assigned by Section 421.095, Government Code.
- 4 SECTION 2. Section 504.103(a), Local Government Code, is
- 5 amended to read as follows:

- 7 501.1031, a Type A corporation may not undertake a project the
- 8 primary purpose of which is to provide:
- 9 (1) a transportation facility;
- 10 (2) a solid waste disposal facility;

- 19 (a) Notwithstanding any other provision of this subtitle, a Type A
- 20 corporation may not use proceeds from the sales and use tax or other
- 21 corporate revenues to undertake the category of projects described
- 22 by Section 501.1031 or the projects described by Section 501.108
- 23 unless the use of tax proceeds or other corporate revenues for those
- 24 purposes is authorized by an election as provided by this section.
- 25 (b) The governing body of a Type A corporation's authorizing
- 26 municipality by resolution may order an election on the question of
- 27 approving the use of sales and use tax proceeds and other corporate

- 9 SECTION 5. Subchapter D, Chapter 505, Local Government
- 10 Code, is amended by adding Section 505.162 to read as follows:
- 11 Sec. 505.162. AUTHORITY TO UNDERTAKE CERTAIN GENERAL
- 12 INFRASTRUCTURE PROJECTS OR PUBLIC SAFETY PROJECTS; ELECTION.
- 13 (a) Notwithstanding any other provision of this subtitle, a Type B
- 14 corporation may not use proceeds from the sales and use tax or other
- 15 corporate revenues to undertake the category of projects described
- 16 by Section 501.1031 or the projects described by Section 501.108
- 17 unless the use of tax proceeds or other corporate revenues for those

- 25 improving, enhancing, or supporting public safety in the City of
- 26 _____."
- 27 SECTION 6. This Act takes effect immediately if it receives

- 1 a vote of two-thirds of all the members elected to each house, as
- 2 provided by Section 39, Article III, Texas Constitution. If this
- 3 Act does not receive the vote necessary for immediate effect, this
- 4 Act takes effect September 1, 2019.
