## A BILL TO BE ENTITLED

AN ACT

- 2 relating to the establishment and duties of the human trafficking
- 3 prevention coordinating council.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter B, Chapter 402, Government Code, is
- 6 amended by adding Section 402.034 to read as follows:
- 7 Sec. 402.034. HUMAN TRAFFICKING PREVENTION COORDINATING
- 8 COUNCIL. (a) In this section, "council" means the human
- 9 <u>trafficking prevention coordinating council.</u>
- 10 (b) The office of the attorney general shall establish the
- 11 human trafficking prevention coordinating council to develop and
- 12 <u>implement a five-year strategic plan for preventing human</u>
- 13 <u>trafficking in this state.</u>
- 14 (c) The council is composed of the following:
- 15 (1) the governor or the governor's designee;
- 16 (2) the attorney general or the attorney general's
- 17 designee;

- 18 (3) the commissioner of the Department of Family and
- 19 Protective Services or the commissioner's designee;
- 20 (4) the public safety director of the Department of
- 21 Public Safety or the director's designee;
- (5) one representative from each of the following
- 23 state agencies, appointed by the chief administrative officer of
- 24 the respective agency:

1	(A) the Texas Workforce Commission;
2	(B) the Texas Alcoholic Beverage Commission;
3	(C) the Parks and Wildlife Department; and
4	(D) the Texas Department of Licensing and
5	Regulation; and
6	(6) one representative of any other state agency
7	appointed by the chief administrative officer of the agency, if the
8	human trafficking prevention task force established under Section
9	402.035 and the council determine that a representative from the
10	state agency is a necessary member of the council.
11	(d) The presiding officer of the council is the attorney
12	general or the attorney general's designee.
13	(e) For each five-year period, the council shall:
14	(1) develop and implement a strategic plan for
15	preventing human trafficking in this state; and
16	(2) submit the strategic plan to the legislature.
17	(f) The strategic plan must include:
18	(1) an inventory of human trafficking prevention
19	programs and services in this state that are administered by state
20	agencies, including institutions of higher education, and
21	<pre>political subdivisions;</pre>
22	(2) regarding the programs and services described by
23	Subdivision (1):
24	(A) a report on the number of persons served by
25	the programs and services; and
26	(B) a plan to coordinate the programs and
27	services to achieve the following goals:

1	(i) eliminate redundancy;
2	(ii) ensure the agencies' use of best
3	practices in preventing human trafficking; and
4	(iii) identify and collect data regarding
5	the efficacy of the programs and services; and
6	(3) in relation to the goals for programs and services
7	as described by Subdivision (2)(B), a plan to coordinate the
8	expenditure of state funds allocated to prevent human trafficking
9	in this state, including the expenditure of state funds by the human
10	trafficking prevention task force established under Section
11	402.035.
12	(g) Not later than December 1 of each year, beginning with
13	the year following the year the council submits a strategic plan to
14	the legislature under Subsection (e)(2), the council shall submit
15	to the legislature an annual report detailing the progress of the
16	strategic plan's implementation. The annual report must include:
17	(1) a description of the level of participation in the
18	strategic plan by each agency represented on the council and how the
19	implementation of the strategic plan serves to coordinate the
20	programs and services described by Subsection (f)(1) and achieve
21	the goals described by Subsection (f)(2)(B); and
22	(2) an update of the inventory of programs and
23	services described by Subsection (f)(1) and how each program or
24	service furthers the goals of the strategic plan.
25	(h) The office of the attorney general shall make available
26	on the office's Internet website the strategic plan and the annual
27	reports required under Subsection (g).

- 1 SECTION 2. Not later than May 1, 2020, the human trafficking
- 2 prevention coordinating council shall submit to the legislature the
- 3 five-year strategic plan required by Section 402.034(e),
- 4 Government Code, as added by this Act.
- 5 SECTION 3. This Act takes effect September 1, 2019.
