## A BILL TO BE ENTITLED

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Chapter 75, Government Code, is amended by
- 6 adding Subchapter J to read as follows:
- 7 SUBCHAPTER J. ACCESS TO BUILDINGS THAT HOUSE COURTS
- 8 Sec. 75.601. STATE BAR MEMBERS. (a) To enter a building
- 9 that houses a justice court, municipal court, county court, county
- 10 court at law, or district court without passing through security
- 11 services, an attorney licensed to practice law in this state may
- 12 present the attorney's security services identification card
- 13 <u>issued under Section 81.117 instead of an identification card</u>
- 14 issued or authorized for issuance by a county or municipality.
- 15 (b) A county or municipality may not adopt or enforce an
- 16 order or ordinance that conflicts with Subsection (a).
- 17 SECTION 2. Subchapter H, Chapter 81, Government Code, is
- 18 amended by adding Section 81.117 to read as follows:
- 19 <u>Sec. 81.117. SECURITY SERVICES IDENTIFICATION CARD. (a)</u>
- 20 The state bar in accordance with this section may issue to a member
- 21 of the state bar a security services identification card that

- 24 75.601. The identification card:

4	(b) A member of the state bar may apply for issuance of a

10	state bar to obtain criminal history record information on the

12	(3) a reasonable fee in the amount set by the state bar

14	portion of the fee to be remitted to a county in accordance with
15	Subsection (c).
16	(c) The state bar shall remit a portion of each fee
17	collected under this section in an amount not less than \$50 as
18	prescribed by state bar rules to the county treasurer, or person
19	performing the functions of the county treasurer, of the county of
20	the applicant's primary practice location. The county may use
21	money the county receives under this subsection only for court
22	security purposes.
23	(d) The state bar shall adopt rules to implement this

Section 411.1005, Government Code, is amended by 11 12 adding Subsection (a-1) to read as follows: (a-1) The State Bar of Texas is entitled to obtain from the 13 14 department criminal history record information maintained by the 15 department that relates to a person who: (1) <u>is licensed by the state bar; and</u> 16 17 (2) applies for issuance of <u>a security services</u> identification card under Section 81.117. 18 19 SECTION 4. Section 291.010, Local Government Code, amended by adding Subsection (d) to read as follows: 20 21 (d) The commissioners court of a county may not adopt or enforce an order that conflicts with Section 75.601, Government 22 23 Code. 24 SECTION 5. As soon as practicable after the effective date

of this Act, the State Bar of Texas shall adopt the rules, fees,
