13	(b-1) Notwithstanding Section 21.402, for the 2019-2020
14	school year, every full-time classroom teacher is entitled to a
15	monthly salary that is at least equal to the sum of:
16	(1) the monthly salary the teacher would have received
17	for the 2019-2020 school year under the district's salary schedule
18	for the 2018-2019 school year, if that schedule had been in effect
19	for the 2019-2020 school year, including any local supplement and
20	any money representing any other supplement the teacher would have
21	received in the 2019-2020 school year; and
22	(2) \$500.
23	(b-2) Subsection (b-1) and this subsection expire September

(b) A school district shall use the amount received under 18 19 this section to provide the salary allotments for full-time classroom teachers required under Section 21.4023. 20 21 (c) A school district that is required to take action under 22 Chapter 41 to reduce its wealth per student to the equalized wealth level is entitled to a credit, in the amount of state aid to which 23 24 the district is entitled under this section, against the total amount required under Section 41.093 for the district to purchase 25 26 attendance credits. 27 (d) The commissioner may adopt rules to implement this
