- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. The heading to Section 51.309, Government Code,
- 6 is amended to read as follows:
- 7 Sec. 51.309. DEPUTY CLERKS AND OTHER EMPLOYEES [CLERK].
- 8 SECTION 2. Section 51.309, Government Code, is amended by
- 9 amending Subsection (b) and adding Subsection (b-1) to read as
- 10 follows:
- 11 (b) Except as provided by Subsection (c), the district clerk
- 12 shall obtain one or more [a] surety bonds in accordance with this
- 13 <u>section</u> [bond] to cover <u>each</u> [a] deputy clerk or <u>other employee.</u>
- 14 The district clerk shall obtain:
- 15 (1) an individual bond for each deputy clerk and other
- 16 employee in an amount for each bond that is equal to the district
- 17 clerk's bond; or
- 18 (2) a schedule surety bond or a blanket surety bond to
- 19 cover <u>all deputy clerks</u> [more than one deputy] and all <u>other</u>
- 20 employees in a total amount that is equal to the district clerk's
- 21 bond [of the office].
- 22 <u>(b-1)</u> A deputy clerk and an employee must be covered by a
- 23 surety bond on the same conditions [and in the same amount] as the
- 24 district clerk. A [The] bond covering a deputy clerk or other

- 1 employee [the deputies and employees] shall be made payable to the
- 2 governor for the use and benefit of the district clerk.
- 3 SECTION 3. Sections 82.002(a) and (c), Local Government
- 4 Code, are amended to read as follows:
- 5 (a) Except as provided by Subsection (b), [If] the county
- 6 clerk [has only a single deputy clerk, the county clerk] shall
- 7 execute one or more [a] surety bonds in accordance with this section
- 8 [bond] to cover each [the] deputy clerk or other employee. The
- 9 county clerk shall execute:
- 10 (1) an individual bond for each deputy clerk and other
- 11 employee in an amount for each bond that is equal to the county
- 12 clerk's bond; or
- 13 (2) a schedule surety bond or a blanket surety bond to
- 14 cover all [the] deputy clerks[, if there is more than one,] and all
- 15 other employees in a total amount that is equal to the county
- 16 <u>clerk's bond</u> [of the office].
- 17 (c) A [The] bond covering a deputy clerk or other [an]
- 18 employee must be conditioned in the same manner as the county
- 19 clerk's bond [and must be for the same amount as the bond for the
- 20 county clerk]. A [The] bond covering a deputy clerk or other
- 21 employee must be made payable to the county for the use and benefit
- 22 of the county clerk.
